

AN ACT RESPECTING THE TOWN OF ST. ALBERT:

WHEREAS the Mayor and Council of the Town of St. Albert, have, by their petition, represented that by a proclamation of the Lieut-Governor, dated the 17th day of August, 1904, and published the 1st. day of September, 1904, the inhabitants of the Town of St. Albert as by said proclamation described, were declared to be a body corporate within the meaning of the Municipal ordinance, and that it was by said proclamation provided that the said Town of St. Albert should consist of the following land, namely: Those parts of River Lots 25, 26, 27, 28, 49, 50, 51, 52, 53, in the St. Albert Settlement, as shown on a plan of survey made by M. Dean, Dominion Land Surveyor, in the Years 1882 and 1883- and approved at Ottawa by E. Deville, on the 2d. day of May, 1884- and more particularly described as follows:

"Commencing at a point on the West boundary of River Lot 25 at a distance of forty chains from the northerly boundary of the said lot; thence N. 45 degrees, 50 min. E. a distance of 65 chains more or less, to the E. boundary of the said River Lot 28- Thence S. - 30 degrees E. following the said East boundary of River Lot 28- 32 chains more or less to the North Bank of the Sturgeon River; Thence S. Westerly following the said Bank of the Sturgeon River to a point on the production of the east boundary of the said River Lot 49- Thence south- 50 degrees- 24 min. east, along said boundary of said River Lot 49 and its production, 41 chains- Thence South - 45 degrees- 50 min. west- 100 chains more or less to a point situated on the production southerly of the aforesaid westboundary of River Lot 25-- Thence N. - 13 degrees, 10 min. west, following the said West boundary of River Lot 25- and its production- 91 chains more or less to <sup>the</sup> a point beginning- containing an area including that portion of the Sturgeon River within the described area- 625 acres more or less."

AND that owing to the rapid growth and development of the said Town of St. Albert, it has become necessary to enlarge the area thereof, and that there are adjacent to the said Town

lands which are convenient, suitable and available for the purposes of enlarging the area of the said Town.

AND WHEREAS application has been made by Petition of the said Mayor and Council for an Act granting to the Town of St. Albert, certain powers and privileges hereinafter set forth:

AND WHEREAS it is desirable and expedient to grant the prayers of the said petition-

NOW THEREFORE, His Majesty by and with the advice and consent of the Legislative Assembly of the Province of Alberta, ENACTS AS FOLLOWS:

1, That the area comprised in the Town of St. Albert as described by the proclamation above mentioned, BE AND THE SAME IS HEREBY EXTENDED by adding thereto so that the area of the said Town shall hereafter be the following: that is to say:

River Lots 23, 24, 25, 26, 27, 28, 29, 30, 31, 47, 48, 49, 50, 51, 52 and 53, in the St. Albert Settlement, as shown on the said plan of survey made by M. Dean, Dominion Land Surveyor, above referred to, including that portion of the Sturgeon River within the described area, and containing by admeasurement 2.434 acres of land, more or less-

2, No assessment shall be made of any of the lands so added to the area of the said town, nor of any portion thereof; nor shall any rate be levied thereon by the said Town for either of the years 1909 or 1910, higher than the assessment or rate which might have been made of or levied on the lands so added, had not the present act been passed.

3, The Council of the Town of St. Albert, in addition to any powers possessed now by it, shall have the power

(a) to grant to the corporation of the city of Edmonton or to any other corporation, Company or individual, operating a railroad, Street Railway or tramway, whether by electricity, steam or other motive power, a franchise, exclusive or non-exclusive for such period not in the first instance to exceed thirty (30) years, as may be thought desirable, to lay its track and build and use its line, in, on or along any street,

lane or avenue of the said Town of St. Albert-

(b) To grant, subject to Part 5- of the Municipal Ordinance, a bonus to any such corporation, Company or individual constructing and operating a railroad, street railway or tramway line within the said Town.

4, Any franchise granted under the preceding section of this Act may be renewed from time to time for such period not to exceed ten years as the Council may determine.
