A BILL TO AMEND THE PUBLIC WORKS ACT

NOTE.

Section 1 of the Bill adds a new subsection (4) to section 27 of the above Act. This section deals with the establishment and operation of public ferries by the Minister of Public Works, and the amendment authorizes the making of regulations by the Minister relating thereto.

Section 2 of the Bill enacts a new section 45*a*. This proposed section authorizes the Minister with the approval of the Lieutenant Governor in Council to make agreements with municipalities for the construction or laying out of municipal works such as parks, swimming pools, etc., the cost of construction to be borne by the Province and municipality jointly. Subsection (3) of the new section authorizes the Minister to carry such agreements into effect and also authorizes the municipalities concerned to enter into and carry out the agreements.

BILL

An Act to amend The Public Works Act.

(Assented to , 1945.)

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. The Public Works Act, being chapter 73 of the Revised Statutes of Alberta, 1942, is hereby amended as to section 27 by adding immediately at the end thereof the following new subsection:

"(4) The Minister may make regulations governing the establishment, control and operation of ferries."

2. The said Act is further amended by adding immediately after section 45 thereof the following new section:

45*a*.—(1) The Minister may with the approval of the Lieutenant Governor in Council enter into an agreement with any city, town, village or municipal district providing for the construction or laying out of municipal public works or the improvement of existing municipal public works such as parks or other public places, public swimming pools, or such other municipal improvements of a like nature as in the opinion of the Minister and of the council of the municipality are desirable.

"(2) Any agreement entered into under the provisions of subsection (1) shall fix the total cost of construction, the period of construction, the proportions of the cost to be provided by the Province and municipality respectively, and the terms upon which and the time or times when payments are to be made by the Province for the purpose aforesaid.

"(3) The Minister is hereby authorized to carry out the terms of any agreement made under the provisions of subsections (1) and (2), and each city, town, village and municipal district is authorized to enter into and carry out any agreement referred to in subsections (1) and (2) which the Minister is thereby authorized to make with the city, town, village or municipal district, as the case may be."

3. This Act shall come into force on the day upon which it is assented to.
