A BILL RESPECTING THE VILLAGE OF INNISFREE

NOTE.

The purpose of this Bill is to validate certain changes made in the area included in the Village of Innisfree by an order of the Minister of Municipal Affairs dated May 22nd, 1929, and effective January 1st, 1929. *The Village Act* had, however, been amended some months previously by transferring the authority to make such changes from the Minister to the Board of Public Utility Commissioners, and this amendment had been overlooked. The order has always been considered as effective both by the owners of the lands affected and by the municipalities concerned, and the proposed Bill validates the order.

# BILL

No. 35 of 1946.

An Act respecting the Village of Innisfree.

(Assented to \_\_\_\_\_, 1946.)

**W**HEREAS under the provisions of *The Village Act*, 1927, being chapter 54 of the Statutes of Alberta, 1927, the Minister of Municipal Affairs was authorized by order to annex to any village any outlying area adjacent thereto and not included within the limits of any city or town and to annex any portion of a village to any adjoining municipality or improvement district;

And whereas the boundaries of the Village of Innisfree were purported to have been altered and adjusted by an Order of the Minister of Municipal Affairs dated May 22nd, 1929, and effective January 1st, 1929, which order annexed certain lands to the Village and annexed a portion of the Village to the Municipal District of Birch Lake No. 484;

And whereas, by reason of an amendment to *The Village Act*, 1927, contained in Chapter 44 of the Statutes of Alberta, 1929, and effective March 20th, 1929, the said authority of the Minister of Municipal Affairs had been transferred to the Board of Public Utility Commissioners and the Minister had no such authority at the date of the order;

And whereas the lands affected by the said Order have at all times since the date of the Order been accepted by the respective taxing authorities and by the owners as being included in the respective municipal areas designated in the said Order;

And whereas subsequent alterations in the boundaries of the Village have been effected by Orders of the Board of Public Utility Commissioners, which Orders have been based in part, on the assumption that the boundaries of the Village were as described in the said Order of the Minister of Municipal Affairs;

And whereas it is considered to be in the public interest that the terms of the Order of the Minister of Municipal Affairs herein referred to be ratified and confirmed:

Now therefore His Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

**1.** Subject to such alterations as may have since been effected by any Order made by the Board of Public Utility Commissioners, the Village of Innisfree shall, as from the first day of January, 1929, be deemed, for all purposes, to have consisted of the following land:

Commencing at the north-east corner of Legal Subdivision 1 of Section 10, Township 51, Range 11, west of the Fourth Meridian, thence southerly along the east limit thereof to a point 150 ft. north of the intersection of said limit with the north limit of North Street, as shown on Registered Plan No. 4175R, thence easterly and parallel to said north limit a distance of 186 ft., thence southerly and parallel to the east limit of said section 10 a distance of 150 ft. to a point on the north limit of North Street aforesaid, thence easterly along the north limit of said street to its intersection with the east limit of East Street as shown on said plan; thence southerly along said east limit to the north-easterly limit of the Canadian National Railway's Station Grounds, as shown on Registered Plan No. 6461R, thence south-easterly along said limit to its intersection with the south-easterly limit of said station grounds, thence south-westerly along said south-easterly limit to its intersection with the south-westerly limit of said station grounds, thence north-westerly along said south-westerly limit to its intersection with the west limit of Section 2, Township 51, Range 11, west of the Fourth Meridian, thence southerly along said west limit to its intersection with the production easterly in a straight line of the south limit of Third Street South, as shown on Registered Plan No. 4175R, thence westerly along said production, and the said south limit of Third Street South, and its production westerly in a straight line to its intersection with the production southerly in a straight line of the west limit of Third Street West, as shown on Registered Plan No. 8776S, thence northerly along said production, and along the westerly limit of Third Street West and its production northerly in a straight line to its intersection with the north limit of Legal Subdivision 1 of the aforesaid Section 10, thence easterly along said north limit to the point of commencement.

**2.** The following land, namely,—

That part of legal subdivision 9 of Section 3, Township 51, Range 11, west of the Fourth Meridian which lies to the south of the south limit of Third Street South and its production westerly as shown on Registered Plan No. 4175R,—

shall, as from the first day of January, 1929, be deemed for all purposes, to have been included in the Municipal District of Birch Lake No. 484 until January 30th, 1942, and thereafter in the Municipal District of Minburn No. 72.

**3.** This Act shall come into force on the day upon which it is assented to.
