A BILL TO AMEND THE MINERAL TAXATION  
ACT, 1947

---

NOTE

The purpose of this Bill is to provide for the vesting of mineral titles in His Majesty under section 23 of the Act without the necessity of the Registrar of the Land Titles Office issuing a new certificate of title. Under the amendment the Registrar will merely make an endorsement of the cancellation of the title with respect to the mineral or minerals on the title of the original owner and thereupon title vests in the Crown.

Section 23 is amended accordingly.

Sections 24 and 25 and Form A of the Schedule are amended to conform to the wording of section 23.

# BILL

No. 20 of 1948.

An Act to amend The Mineral Taxation Act, 1947.

(Assented to , 1948.)

**H**IS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

**1.** *The Mineral Taxation Act, 1947*, being chapter 10 of the Statutes of Alberta, 1947, is hereby amended as to section 23 by striking out the words "and shall issue a new certificate of title to the mineral or minerals free and clear of all encumbrances in the name of His Majesty in the right of the Province as represented by the Minister", where the same occur in subsection (2) thereof, and by substituting therefor the words "and thereupon title to the said mineral or minerals free and clear of all encumbrances shall vest in His Majesty in the right of the Province as represented by the Minister."

**2.** The said Act is further amended as to section 24 by striking out the words "Until title has been issued in the name of His Majesty", where the same occur therein and by substituting therefor the words "Until the certificate of title of the owner with respect to the mineral or minerals has been cancelled and title has vested in His Majesty".

**3.** The said Act is further amended as to section 25 by striking out the words "and upon the issue by the Registrar of a certificate of title in the name of His Majesty", where the same occur therein and by substituting therefor the words "and upon the cancellation by the Registrar of the certificate of title of the owner with respect to such mineral or minerals, title shall vest in His Majesty and".

**4.** The said Act is further amended as to Form A in the Schedule by striking out the same and by substituting therefor the following:

"FORM A.

"NOTICE

"To the Registrar of the  
Alberta Land Registration District.

"Take notice pursuant to section 23 of *The Mineral Taxation Act, 1947*, being chapter 10 of the Statutes of Alberta, 1947, as amended from time to time, that in respect of the mineral or minerals contained in each certificate of title set

out in the Schedule attached to this Notice, you are required to cancel the certificate of title of the owner in respect of the mineral or minerals contained in each certificate of title set out in the said Schedule, whereupon pursuant to the said section title to the said mineral or minerals, free and clear of all encumbrances, shall vest in His Majesty in the right of the Province of Alberta as represented by the Minister of Lands and Mines.

**5.** This Act shall come into force on the day upon which it is assented to.
