# A BILL TO AMEND THE ALBERTA LIVE STOCK AND LIVE STOCK PRODUCTS ACT.

### NOTE.

This Bill amends *The Alberta Live Stock and Live Stock Products Act*, being chapter 88 of the Revised Statutes of Alberta, 1942.

Section 4 is amended. The word "order" is struck out of subsections (1) and (2) and the word "regulation" is substituted. The word "regulation" is defined in the interpretation section and it is used elsewhere throughout the Act. This section deals with regulations made by the Lieutenant Governor in Council and it would appear to be more appropriate to use the term "regulation" rather than the term "order".

Section 4 (1) (b) is struck out and two new paragraphs are substituted instead. The first paragraph enables the Lieutenant Governor in Council to prescribe designated areas and to make special rules and regulations applicable to such designated areas relating to licensing, grading, packing, marking and sale of live stock and live stock products in such designated areas. The second paragraph substituted is similar to the one which was struck out, having been reworded for purposes of clarification only.

Section 4 (6) is struck out and a new subsection is substituted. The effect of this amendment is to enable licensing of producers who sell directly to retailers or consumers.

# BILL

#### No. 87 of 1949.

An Act to amend The Alberta Live Stock and Live Stock Products Act.

(Assented to , 1949.)

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

- 1. The Alberta Live Stock and Live Stock Products Act, being chapter 88 of the Revised Statutes of Alberta, 1942, is hereby amended as to section 4,—
  - (a) by striking out the word "order", wherever it occurs in subsections (1) and (2), and by substituting the word "regulation";
  - (b) by striking out paragraph (b) of subsection (1) and by substituting the following:
    - "(b) prescribe designated areas and make regulations applicable to such designated areas,—
      - "(i) prescribing classes of licenses which may be issued in a designated area and prohibiting the issue of other classes of licenses;
      - "(ii) prescribing classes of persons who may deal in live stock or live stock products or both in a designated area and prohibiting other persons from dealing therein;
      - "(iii) prescribing minimum requirements for grading, packaging and marketing of live stock or live stock products or both which are sold by or which are sold to any class or classes of persons in a designated area;
      - "(iv) prohibiting dealing by or with unlicensed persons in a designated area;
      - "(v) providing in a designated area for the regulation of any other matter or thing which the Lieutenant Governor in Council is empowered to regulate pursuant to this Act in any area which is not a designated area;
    - "(bb) determine the manner in which any person so licensed shall deal in any live stock or live stock products in respect of which he is required to be licensed and prohibit or restrict any practice, system or method of dealing in any live stock or live stock products;";

- (c) by striking out subsection (6) and by substituting the following:
  - "(6) Nothing in this section shall apply to a farmer or rancher who buys and sells live stock in the ordinary course of his farming or ranching operations, except a farmer or rancher who sells directly to consumers or retailers in a designated area.".
- 2. This Act shall come into force on the day upon which it is assented to.
