#### Bill No. 94 of 1949.

A BILL TO PROVIDE FOR THE PAYMENT OF GRANTS TO MUNICIPALITIES IN LIEU OF TAXES ON CERTAIN CROWN PROPERTIES.

#### NOTE.

This Bill enacts a new Act to be known as "The Crown Property Municipal Grants Act".

The Act defines "Crown commercial enterprise" as including The Alberta Liquor Control Board and Marketing Services Limited. It also defines "Crown property" as meaning any property belonging to the Crown in the right of the Province which is occupied by any Crown commercial enterprise or by any person, firm, corporation, board, Crown corporation or other agency of the Crown that pays rent to the Department of Public Works.

Section 3 of the Bill enables the Provincial Treasurer to pay to each municipality in lieu of taxes on Crown property such amount as may be approved by the Lieutenant Governor in Council.

Section 4 provides that all moneys payable by the Provincial Treasurer under this Act shall be paid out of moneys appropriated by the Legislative Assembly for that purpose.

An Act to provide for the Payment of Grants to Municipalities in Lieu of Taxes on Certain Crown Properties.

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

#### SHORT TITLE.

1. This Act may be cited as "The Crown Property Municipal Grants Act".

#### INTERPRETATION.

- 2. In this Act, unless the context otherwise requires,—
  - (a) "Crown commercial enterprise" includes:
    - (i) The Alberta Liquor Control Board;
    - (ii) Marketing Services Limited;
  - (b) "Crown property" means any property belonging to the Crown in the right of the Province which is occupied by any Crown commercial enterprise or by any person, firm, corporation, board, Crown corporation or other agency of the Crown that pays rent to the Department of Public Works;
  - (c) "municipality" means any city, town, village, municipal district, improvement district or special area.
- **3.** The Provincial Treasurer may pay to each municipality in lieu of taxes on Crown property such amount as may be approved by the Lieutenant Governor in Council.
- 4. All moneys payable by the Provincial Treasurer to any municipality pursuant to this Act shall be paid out of any moneys that may be appropriated by the Legislative Assembly for that purpose.
- 5. This Act shall come into force on the day upon which it is assented to.
