WHEREAS the Calgary and Southwestern Railway Company has presented a petition praying for the amendment as hereinafter set forth of the Act incorporating the said Company, being chapter 57 of the Statutes of Alberta, 1918, as amended, and it is expedient to grant the prayer of the said Petition: Preamble

Therefore His Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. The following new section 1a is added immediately after section 1: New section
1a

“1a. This Act may be cited as ‘*The Calgary and Southwestern Railway Company Act*.’”. Short title

2. Section 13 is struck out and the following is substituted: Section 13
amended
“**13.** That the construction of the railway hereby authorized shall be commenced within five years, and shall be completed within ten years from the thirty-first day of Commence-
ment and
completion
of railway”

March, 1951, and section 70 of *The Railway Act*, being chapter 197 of the Revised Statutes of Alberta, 1942, shall not apply to the said Company.”.
