Therefore His Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

**1.** The following new section 1a is added immediately New section 1aafter section 1:

"1a. This Act may be cited as 'The Calgary and South- Short title western Railway Company Act'.".

2. Section 13 is struck out and the following is substituted: Section 13 "13. That the construction of the railway hereby author- Commenceized shall be commenced within five years, and shall be ment and completed within ten years from the thirty-first day of completion of railway
