### A BILL TO AMEND THE MUNICIPAL DISTRICTS' OFFICE EMPLOYEES' SUPERANNUATION ACT, 1948.

#### NOTE.

This Bill amends The Municipal Districts' Office Employees' Superannuation Act, 1948, being chapter 93 of the Statutes of Alberta, 1948.

Sections 2 and 6 are amended by including the employees of Counties under the provisions of the Act.

Section 21 is amended by renumbering the section as subsection (1) and by adding three new subsections. Section 21 provides for superannuation at the basic rate of three hundred dollars per annum.

Subsection (2) provides that in addition to the basic superannuation allowance every superannuated employee shall be paid a monthly allowance for a period of ten years totalling in each year an amount equal to one-tenth of his contributions made under section 12(2).

Subsection (3) provides that this monthly allowance shall be paid in each month on the same day on which the superannuation allowance is payable.

Subsection (4) provides that if the superannuated employee dies before he has received monthly allowances totalling the amount of his contributions, the Board shall pay to his heirs or to his estate the difference between the total of his monthly allowances and the total amount of his contributions.

# BILL

#### No. 3 of 1951.

#### An Act to amend The Municipal Districts' Office Employees' Superannuation Act, 1948.

### (Assented to , 1951.)

**H**<sup>IS</sup> MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

**1.** The Municipal Districts' Office Employees' Superannuation Act, 1948, being chapter 93 of the Statutes of Alberta, 1948, is hereby amended as to section 2,—

- (a) by adding immediately after the words "Municipal District" where they occur in clause (d) the words "or a County,".
- (b) by adding immediately after the words "Municipal District" where they occur in clause (e) the words "or a County".

2. The said Act is further amended as to section 6 by adding immediately after the words "municipal districts" the words "or counties".

**3.** The said Act is further amended as to section 21,—

- (a) by renumbering the same as subsection (1);
- (b) by adding immediately after subsection (1) the following new subsections:

"(2) In addition to the superannuation allowance provided for in subsection (1) every superannuated employee shall be paid a monthly allowance for a period of ten years, totalling in each year an amount equal to one-tenth of his contributions made under section 12, subsection (2).

"(3) The monthly allowance shall be paid in each month on the same day on which the superannuation allowance is payable.

"(4) If the superannuated employee dies before he has received monthly allowances totalling the amount of his contributions made under section 12, subsection (2), the Board shall pay to his heirs or estate the difference between the total of his monthly allowances and the total amount of his contributions under section 12, subsection (2).".

4. This Act shall come into force on the first day of July, 1951.
