#### Bill No. 48 of 1952.

#### A BILL TO AMEND THE DENTAL ASSOCIATION ACT.

## NOTE.

This Bill amends The Dental Association Act, being chapter 291 of the Revised Statutes of Alberta, 1942.

Section 4 is amended. The effect of the amendment is to change the number of the election districts set up for the purpose of electing the directors of the board of the dental association. Instead of five districts there are now four, namely, the southern, Calgary, central and Edmonton districts. The amendment to this section also fixes the number of directors each district may elect to the board of directors. The southern district elects one; the Calgary district two; the central district one and the Edmonton district elects three. The amended section also provides that in 1952 the southern district shall elect a member to the board for a term of one year and shall elect its member every second year thereafter. The central district and the Calgary district shall elect one member each in 1952 and one member every second year thereafter; the Edmonton district elects two members in 1952 and every second year thereafter, while the remaining members from the Calgary and Edmonton districts are to be elected in 1953 and every second year thereafter.

Section 11, subsection (2) is amended by providing that, by the by-law delegating duties of a dental nature to a class or classes of persons not members of the association, the board may make provision for the discipline of any member of a class to which such duties have been delegated.

This Bill comes into force upon assent.

# No. 48 of 1952.

An Act to amend The Dental Association Act.

## (Assented to , 1952.)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

**1.** The Dental Association Act, being chapter 291 of the Revised Statutes of Alberta, 1942, is hereby amended.

Section 4 amended **2.** Section 4 is amended:

- (a) by adding immediately at the end of subsection (1) the words ", except as otherwise provided in subsection (4)";
- (b) by striking out subsections (2), (3) and (4) and by substituting the following:

"(2) For the purposes of the election of directors under this Act, the Province shall be divided into the following four districts:

- "(a) the southern Alberta district, comprising all that part of the Province lying south of the north border of township 19;
- "(b) the Calgary district, comprising all that part of the Province between the north boundary of township 19 and the north border of township 27;
- "(c) the central district, comprising that part of the Province north of the north boundary of township 27 to the following line beginning at the north boundary of township 49 on the Saskatchewan-Alberta border; thence west on this line to its intersection with the Saskatchewan river; thence along the Saskatchewan river to the north boundary of township 44; thence west on this line to its intersection with the Alberta-British Columbia boundary;
- "(d) the Edmonton district, comprising all that part of the Province lying north of the central district.

"(3) The southern district shall be entitled to elect one member to the Board of Directors; the Calgary district shall be entitled to elect two members to the Board; the central district shall be entitled to elect one member to the Board and the

Electoral districts Edmonton district shall be entitled to elect three members to the Board, of whom one shall be from the area outside the city of Edmonton and the members of the Association resident in each district shall be entitled to vote only for members to be elected for that district.

"(4) The member of the Board for the southern district shall be elected in the year 1952 for a term of one year and every second year thereafter.

"(4a) One member from the central district and one member from the Calgary district and two members from the Edmonton district shall be elected in the year 1952 and every second year thereafter; one member from the Calgary district and one member from the Edmonton district shall be elected in the year 1953 and every second year thereafter."

**3.** Section 11 is amended by adding at the end of sub-section 11 section (2) the words "and may by the by-law make provision for the discipline of any member of a class to which duties of a dental nature as specified in the by-law have been delegated".

4. This Act shall come into force on the day upon which Coming into force it is assented to.
