A BILL TO AMEND THE MAINTENANCE ORDERS (FACILITIES FOR ENFORCEMENT) ACT.

Note.

This Bill amends The Maintenance Orders (Facilities for Enforcement) Act, being chapter 13 of the Statutes of Alberta, 1947.

Section 2 is amended to define "Reciprocating State" so as to include those provinces and territories to which the Imperial Act intituled the *Maintenance Orders* (Facilities for Enforcement) Act, 1920 does not extend, such as for example the North-West Territories. The Republic of Ireland is particularly mentioned as it does not come within the classification of a Dominion.

Section 12 is amended to conform to the amendment to section 2.

This Bill comes into force upon assent and is retroactive to the 1st day of November, 1951.

An Act to amend The Maintenance Orders (Facilities for Enforcement) Act.

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

- 1. The Maintenance Orders (Facilities for Enforcement) Act, being chapter 13 of the Statutes of Alberta, 1947, is hereby amended.
- **2.** Section 2 is amended by striking out clause (g) and by section 2 substituting the following:
 - "(g) 'Reciprocating State' means any part of Her Ma- "Reciprojesty's Dominions that has been declared a recipro- cating State" cating State for the purposes of this Act, and includes the Republic of Ireland if it is declared to be a reciprocating State as aforesaid;".

3. Section 12 is amended,—

Section 12 amended

- (a) by striking out subsection (1) and by substituting the following:
 - "12. (1) Where the Lieutenant Governor in Application Council is satisfied that reciprocal provisions have of Act to reciprocating been made by the Legislature of any part of Her States Majesty's Dominions or of the Republic of Ireland for the enforcement of maintenance orders made within Alberta, the Lieutenant Governor in Council by order may declare such part of the Republic to be a reciprocating State for the purposes of this Act, and thereupon that part, or the Republic of Ireland, shall become a reciprocating State within the meaning of this Act.";
- (b) by striking out the words "outside England and Northern Ireland" where they occur in subsection (2) and by substituting the words "or the Republic of Ireland".
- 4. This Act shall come into force on the day upon which coming into force it is assented to, and upon so coming into force shall be deemed to have been in force at all times on and after the first day of November, 1951.
