## A BILL AN AMEND THE MUNICIPAL DISTRICTS' OFFICE EMPLOYEES' SUPERANNUATION ACT, 1948

#### Note

This Bill amends The Municipal Districts' Office Employees' Superannuation Act, 1948, being chapter 93 of the Statutes of Alberta, 1948, for the purpose of broadening the scope of the Act to include all permanent employees of municipal districts, counties, towns, villages, school divisions (excepting school teachers), hospital districts and the Alberta Association of Municipal Districts.

# BILL

### No. 3 of 1953

#### An Act to amend The Municipal Districts' Office Employees' Superannuation Act, 1948

# (Assented to , 1953)

WHEREAS a petition has been presented praying for the amendment of *The Municipal Districts' Office Employees' Superannuation Act, 1948*, being chapter 93 of the Statutes of Alberta, 1948, and it is expedient to grant the prayer of the petition:

Therefore, Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

**1.** The Municipal Districts' Office Employees' Superannuation Act, 1948, being chapter 93 of the Statutes of Alberta, 1948, is hereby amended.

Title amended 2. The Act is amended by striking out the words "Municipal Districts' Office Employees'", wherever they occur in the short title and in the body of the Act, and by substituting the words "Municipal Districts Employees'".

Section 2 amended

"employee"

''employer''

Sections 6 and 7 amended Contracts and agreements **3.** Section 2 is amended by striking out clauses (d) and (e) and by substituting the following:

- "(d) 'employee' means a person, male or female, employed by a municipal district, county, town, village, school division, hospital district or the Alberta Association of Municipal Districts, and who has been designated by the council of such municipal district, county, town or village, or by the trustees of such school division, or by the board of such hospital district, or by the secretary of the Alberta Association of Municipal Districts as a permanent employee, but does not include a school teacher,
- "(e) 'employer' means municipal district, county, town, village, school division, hospital district or the Alberta Association of Municipal Districts.".

4. Sections 6 and 7 are struck out and the following are substituted:

"6. The Board may enter into such contracts and agreements with municipal districts, counties, towns, villages, school divisions, hospital districts or other persons or bodies as may be necessary to carry into effect the intent and purpose of the Act.

.....

"7. The Association, Secretary-Treasurers' Association Grants and any other body or individual interested in municipal school or hospital government may make grants to the fund and the Board may accept grants so made.".

5. Section 11 is struck out and the following is sub-  $_{\rm amended}^{\rm Section\ 11}$  stituted:

"11. (1) An employer, by by-law of its council or of the <sup>Contributions</sup> school division board of trustees or of the members of a hospital board, as the case may be, may agree to contribute to the fund for the employee or employees named in the said by-law the annual amount hereinafter set out.

"(2) Passage of the said by-law and notice thereof to the Board, whether before or after the coming into force of this Act, shall constitute an agreement between the employer and the Board, which shall continue from year to year until terminated by the employer giving to the Board a clear twelve months' notice of its intention to terminate the agreement.

"(3) Upon the giving of such notice, the said agreement  $\frac{\text{Effective}}{\text{date of}}$  shall terminate and be at an end as of the thirty-first day of  $\frac{\text{termination}}{\text{notice}}$ 

"(4) Any defect in the passing of the said by-law shall Validity of not invalidate the said agreement.".

6. This Act comes into force on the first day of July,  $\frac{Coming into}{force}$  1953.
