#### An Act respecting The Galt Hospital

#### (Assented to

WHEREAS The Galt Hospital is a Corporation whose Constitution is embodied and set forth in chapter 58 of the Statutes of Alberta of the year A.D. 1913; and

Whereas the said Corporation, The Galt Hospital, has for many years maintained and operated a general hospital in the City of Lethbridge; and

Whereas the City of Lethbridge is now included in and is a part of the Lethbridge Municipal Hospital District No. 65 of the Province of Alberta and the Board of the said Municipal Hospital District is now erecting a general hospital on a site in the City of Lethbridge, which said hospital is expected to be completed and in operation not later than the 31st day of December, A.D. 1954, after which said occurrence it will no longer be necessary or advisable for the Board of Management of The Galt Hospital to continue to maintain and operate the hospital of the said Corporation; and

Whereas by far the greater portion of the funds required for the erection and extensions of the buildings of The Galt Hospital, as well as a considerable portion of the site whereon said buildings are situate, has been provided by The City of Lethbridge; and

Whereas the Board of Management of The Galt Hospital and the City of Lethbridge have by their petition prayed that it be enacted as hereinafter set forth, and it is expedient to grant the prayer of the said Petitioners:

Therefore Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. The Galt Hospital, the Corporation whose Constitution Dissolution is embodied and set forth in chapter 58 of the Statutes of Hospital Alberta of the year A.D. 1913, shall be dissolved on the first day of January, A.D. 1955.

2. The corpus of the bequest to which the said The Galt Bequest of Hospital is entitled under the Will of Mary Ann Fleming, of Heming Lethbridge, in the Province of Alberta, Widow, deceased, together with all accrued income derived therefrom, shall on or before the 31st day of December, A.D. 1954, be paid over

by British Canadian Trust Company, the Executor of the Will of the said deceased, to The Board of the Lethbridge Municipal Hospital No. 65 of the Province of Alberta, and shall be used by the said Board for the following purposes, namely:

- (a) to provide a library for a school of nursing to be operated by the said Board under the name of The Galt School of Nursing in connection with its general hospital at the City of Lethbridge, and
- (b) to provide furnishings for the said library and furnishings for the said school.

Trust funds held by The Royal Trust ter 58 of the Statutes of Alberta of the year A.D. 1913 were Company transferred to The Boyal Trust Company a body Corporate transferred to The Royal Trust Company, a body Corporate, with head office at the City of Montreal, in the Province of Quebec, by Deed of Gift dated the 21st day of February, A.D. 1914, shall remain with and be held by the said The Royal Trust Company upon the same terms, conditions and trusts as are set forth in the said Deed of Gift, excepting only that the income arising from the said trust funds subsequent to the 31st day of December, A.D. 1954, shall be paid over yearly or half yearly by the said Trustee, The Royal Trust Company, to the Board of the Lethbridge Municipal Hospital District No. 65, of the Province of Alberta, subject to the condition that the said Board shall use the said income so paid to it for the following purposes, namely:

- (a) a one-half share or portion thereof to provide scholarships for nurses-in-training at the School of Nursing which pursuant to section 2 of this Act is to be operated by the said Board under the name of The Galt School of Nursing, and to provide postgraduate courses for graduates of the said school, the said scholarships to be known as The Sir Alexander T. Galt Scholarships.
- (b) the other half share or portion of the said income toward the maintenance and operation of the said The Galt School of Nursing.

Property of The Galt

4. (1) On the 31st day of December, A.D. 1954, all the property both real and personal, of every kind and nature Hospital property both real and personal, of every kind and nature vested in the whatsoever then vested in or belonging to the said Corpor-city of ation. The Galt Hospital excepting only the Trust Funds ation. The Galt Hospital excepting only the Trust Funds mentioned in sections 2 and 3 of this Act, shall be vested in The City of Lethbridge as the owner thereof, and The City of Lethbridge shall become liable for and be charged with all the then outstanding debts, liabilities. contracts, engagements and obligations of the said Corporation, The Galt Hospital.

> (2) The property so vested in The City of Lethbridge shall, without in any way restricting the generality of the foregoing, be deemed to include all the goods, chattels, moneys, credits, debts, bills, notes, choses in action, con

tracts, agreements and securities whatsoever and wheresoever of the said The Galt Hospital, excepting only the trust funds above mentioned, and shall also be deemed to include all lands, buildings and hereditaments then belonging to the said The Galt Hospital whether acquired in the name of The Galt Hospital either before or after the passing of chapter 58 of the Statutes of Alberta of the year A.D. 1913, and the Registrar of Land Titles for the South Alberta Land Registration District shall upon application in writing to him made by The City of Lethbridge at any time subsequent to the 31st day of December, A.D. 1954, cancel the Certificate or Certificates of Title to all lands then standing in the Register in the name of The Galt Hospital, and shall issue a new Certificate of Title or new Certificates of Title to the said lands in the name of the City of Lethbridge as the owner thereof.

5. This Act comes into force on the day upon which it Coming into is assented to.
