An Act to amend the Act Incorporating the Roman Catholic Bishop of the Apostolic Vicariate of Athabasca and the Roman Catholic Parishes and Missions in the Apostolic Vicariate of Athabasca

(Assented to _____, 1954)

WHEREAS La Corporation Episcopale Catholique Romaine d'Grouard has prayed for an amendment to chapter 50 of the Statutes of Alberta, 1914, being "*An Act to Incorporate the Roman Catholic Bishop of the Apostolic Vicariate of Athabasca and the Roman Catholic Parishes and Missions in the Apostolic Vicariate of Athabasca*", and it is expedient to grant the prayer of the said petition;

Preamble

Therefore, Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. *An Act to Incorporate the Roman Catholic Bishop of the Apostolic Vicariate of Athabasca and the Roman Catholic Parishes and Missions in the Apostolic Vicariate of Athabasca*, being chapter 50 of the Statutes of Alberta, 1914, is hereby amended.

2. The following new section is added immediately after section 7:

New section 7a

"7a.(1) The following parcels of land, each not exceeding three (3) acres, together with buildings, equipment and furnishings of and belonging to La Corporation Episcopale Catholique Romaine d'Grouard as long as the same are used and occupied for educational purposes are exempt from taxation except for local improvement taxes and taxes pertaining to minerals and shall be deemed to have been so exempt as of January 1st, 1953:

Exemption from taxation

"(a) the northerly two hundred (200) feet of the easterly six hundred (600) feet of the lands described in Certificate of Title 7-Y-94 and being the north-west quarter of section thirty-six (36), township seventy-five (75), range twenty-one (21), west of the fifth (5th) meridian, being located at Guy, Alberta,

"(b) Lot eighteen (18) in Block One (1) Plan 525 H.W. being a portion of the land described in Certificate of Title 44-V-124 and being located at Tangent, Alberta,

“(c) the easterly two hundred (200) feet of the westerly eight hundred and seventy (870) feet of the southerly two hundred (200) feet of those lands described in Certificate of Title 226-I-122 and being the south-west quarter of section one (1), township eighty (80), range twenty-two (22), west of the fifth (5th) meridian, being located at Jean Cote, Alberta,

“(d) Blocks A, B and C, Plan 6981 E.T. New Girouxville being those lands described in Certificate of Title 245-T-107 and being located in New Girouxville, Alberta,

“(e) Lots one to twenty-five (1-25) inclusive in Block nine (9), Plan 3762 H.V. Girouxville, being those lands described in Certificate of Title 164-P-141 and located in the vicinity of Girouxville, Alberta.

Medical or
hospital
expenses

“(2) La Corporation Episcopale Catholique Romaine d’Grouard shall be responsible for the medical and hospital services of persons not residents of the municipal district in which the tax exempt land of the corporation is located during the period such persons are dwelling on the said lands and shall reimburse the hospital district in which the said lands are situate for any medical or hospital expenses incurred by the said hospital district or municipal district by reason of the hospitalization of any such person in a hospital.

Coming into

3. This Act comes into force on the day upon which it is assented to.
