# A BILL TO AMEND THE AGRICULTURAL SOCIETIES ACT

### Note

This Bill amends *The Agricultural Societies Act*, being chapter 246 of the Revised Statutes of Alberta, 1942.

Section 3, clause (e) is amended for the purpose of combining the skills referred to in subclauses (iii), (v) and (vi) into classifications without reference to particular skills such as plowing, blacksmithing, sewing, etc.

Section 33 is amended. Subsection (2), clause (a), is struck out and a new clause (a) is substituted. The effect of the amendment is to permit the payment of a grant (out of moneys appropriated by the Legislative Assembly for the aid of agricultural societies) based on a percentage of the amount actually paid in prizes not exceeding a maximum sum and which will be paid in accordance with the provisions set up by the Lieutenant Governor in Council. Previously it was provided that where the amount paid in prizes exceeded three hundred dollars a grant equal to fifty per cent of the amount could be made but the grant could not exceed fifteen hundred dollars in the case of a Class B fair and four hundred dollars in the case of a fair that did not qualify as a Class B fair.

This Bill comes into force upon assent.

# BILL

### No. 50 of 1954

An Act to amend The Agricultural Societies Act

### (Assented to , 1954)

**H**ER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. The Agricultural Societies Act, being chapter 246 of the Revised Statutes of Alberta, 1942, is hereby amended.

**2.** Section 3, clause (e) is amended

Section 3 amended

- (a) by striking out subclause (iii) and by substituting the following:
  - "(iii) proficiency in farming and homemaking operations and skills and in skills related thereto;",
- (b) by striking out subclauses (v) and (vi).

**3.** Section 33, subsection (2) is amended by striking out Section 33 clause (a) and by substituting the following:

"(a) for conducting an exhibition or fair, a grant based on a percentage of the amount actually paid in prizes and not exceeding a maximum sum which may be fixed by the Lieutenant Governor in Council and which shall be paid in such manner and in accordance with such provisions as the Lieutenant Governor in Council determines,".

4. This Act comes into force on the day upon which it Coming into force is assented to.
