

Bill No. 14 of 1955

A BILL RESPECTING THE LEGISLATIVE
ASSEMBLY OF ALBERTA

NOTE

This Bill enacts *The Legislative Assembly Act, 1955*, which repeals and replaces chapter 4 of the Revised Statutes of Alberta, 1942 entitled *The Legislative Assembly Act*, and first enacted in 1909.

The Legislative Assembly Act, 1955, is a revision and consolidation of the Act for which it is being substituted.

This Bill comes into force upon assent.

BILL

No. 14 of 1955

An Act respecting the Legislative Assembly of Alberta

(Assented to _____, 1955)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. This Act may be cited as "*The Legislative Assembly Act, 1955*". Short Title

Representation of Electoral Divisions

2. Until the Legislature otherwise provides, the Legislative Assembly shall be composed of sixty-one members to represent the electoral divisions mentioned in Schedule 1 to this Act. Composition of Assembly

3. (1) Each of the electoral divisions mentioned and defined in Schedule 1 to this Act is entitled to return one member, except the electoral divisions of Edmonton and Calgary. Number of members in electoral divisions

(2) The electoral division of Edmonton is entitled to return seven members and the electoral division of Calgary is entitled to return six members.

Duration of Assembly

4. (1) A Legislative Assembly summoned or called in and for the Province is not determined or dissolved by the demise of the Crown, but continues and may meet, convene and sit, proceed and act, notwithstanding the demise of the Crown, in the same manner as if the demise had not happened. Effect of demise of Crown

(2) Nothing in this section alters or abridges the power of the Crown to prorogue or dissolve the Legislative Assembly. Power of Crown to prorogue Assembly

5. Subject to being sooner dissolved by the Lieutenant Governor, every Legislative Assembly shall continue for five years from the date of the return of the writs for the election, but no longer. Duration of Assembly

6. There shall be a session of the Legislature once at least in every year, so that twelve months will not intervene between the last sitting of the Legislature in one session and its first sitting in the next.

7. It is not necessary for the Lieutenant Governor in proroguing the Legislature to name any day to which it is prorogued, or to issue a formal proclamation for a meeting of the Legislature when it is not intended that the Legislature meet for the despatch of business.

Disqualification as Members

8. A member of the Senate or of the House of Commons of Canada is not eligible to be a member of the Legislative Assembly.

9. (1) If a member of the Legislative Assembly sits or votes as a member of the House of Commons of Canada

(a) his seat in the Legislative Assembly is thereby vacated, and

(b) he becomes incapable of sitting or voting in the Legislative Assembly,

and a writ shall issue for a new election in the manner provided in this Act.

(2) A person is not eligible for re-election as a member of the Legislative Assembly so long as he continues to be a member of the House of Commons of Canada.

10. (1) Except as hereinafter particularly provided, a person

(a) accepting or holding any office, commission or employment either

(i) in the service of the Government of Canada, or

(ii) in the service of the Government of Alberta, at the nomination of the Crown or of the Lieutenant Governor and to which is attached a salary, or any fee, allowance or emolument in lieu of a salary, from the Crown or from the Province, or

(b) accepting or holding any office, commission, or employment of profit at the nomination of the Crown, or of the Government, or of any head of a department in the Government of Alberta, whether the profit is or is not payable out of the public funds,

is not eligible to be a member of the Legislative Assembly, or to sit or vote in the Legislative Assembly during the time he holds the office, commission or employment.

- (2) This section does not apply to Non-application of section
- (a) the Speaker or Deputy Speaker of the Legislative Assembly, or
 - (b) any member to whom, as the recognized leader of any party or group of members, any special allowance is paid pursuant to a resolution of the Legislative Assembly.

(3) Notwithstanding any other provisions of this Act, a member of the Legislative Assembly does not become ineligible to be a member thereof nor does his seat become vacated by reason of his accepting or holding any of the following offices, namely: President or Chairman of the Council, Attorney General, Provincial Secretary, Minister of Agriculture, Minister of Public Works, Minister of Education, Minister of Health, Minister of Municipal Affairs, Minister of Telephones, Minister of Lands and Forests, Minister of Mines and Minerals, Minister of Public Welfare, Minister of Industries and Labour, Minister of Economic Affairs, Minister of Highways, Provincial Treasurer, or the Minister or head of any other public department that may hereafter be organized by statute of this Province. Eligibility of certain persons as members

- (4) Nothing in this section renders
- (a) any person who is a member of the Executive Council,
 - (b) any officer of Her Majesty's Army, Navy or Air Force,
 - (c) any officer in the militia or militiaman, except officers on the staff of the militia receiving permanent salaries, or
 - (d) any justice of the peace, coroner or notary public,
- ineligible to be a member of the Legislative Assembly.

11. (1) A person holding or enjoying, undertaking or executing, directly or indirectly, alone or with any other, by himself or by the interposition of a trustee or third party, any contract or agreement Ineligibility of contractor as member

- (a) with the Crown, or with any public officer or department, with respect to the public service of Alberta, or
 - (b) under which any public money of Alberta has been paid to and accepted by any such person for any service or work, matter or thing,
- is not eligible to be a member of the Legislative Assembly or to sit or vote in the Legislative Assembly.

- (2) Subsection (1) does not apply to Non-application of section
- (a) a contract of or agreement for insurance entered into by a member of the Legislative Assembly with The Alberta General Insurance Company or The Life Insurance Company of Alberta, or

- (b) a contract or an agreement entered into by a member of the Legislative Assembly with Her Majesty or any public officer or department of the Public Service of Alberta for the purchase of a retirement annuity under the provisions of *The Retirement Annuities Act*,
 - (c) a contract or an agreement entered into by a member of the Legislative Assembly with Her Majesty or a public officer or department of the Public Service of Alberta for the deposit of moneys in a treasury branch under *The Treasury Branches Act* or for the borrowing of money therefrom in the ordinary operation of a treasury branch.
- (3) Subsection (1) does not apply to
- (a) a contract or agreement under which medical, surgical or other health services are rendered or any goods are sold or delivered to any person who is in receipt of an old age pension or indigent or unemployment relief, or
 - (b) a contract of agency between The Alberta General Insurance Company and a member of the Legislative Assembly, or
 - (c) the receipt by a member of the Legislative Assembly of any bonus or bonuses paid under an agreement between the Government of Canada and the Province to any class of persons with respect to goods produced by them,

notwithstanding that public money of Alberta has been paid on account of any such services being rendered or of any goods being so sold and delivered or on account of such agency or such bonus or bonuses.

Compensation for land required by highway

(4) Subsection (1) does not prevent a member of the Legislative Assembly from receiving compensation for land that has been acquired by the Highways Department for the right of way of a highway or for a road allowance

- (a) if the member of the Legislative Assembly has been the owner of the land for not less than three years, and
- (b) if the compensation payable is fixed by a district court judge upon an application made by and at the expense of the Highways Department.

Eligibility for nomination as candidate

12. No person is eligible

- (a) to be nominated as a candidate,
- (b) to be a member of the Legislative Assembly, or
- (c) to sit or vote in the Legislative Assembly,

unless at the time of his nomination he would have been entitled to be placed on a list of voters of an electoral division of Alberta if the same were then being compiled.

Persons not ineligible for membership

13. No person is ineligible to be a member of the Legislative Assembly by reason of his being

- (a) interested only as an executor, administrator or

trustee, and having otherwise no beneficial interest in a contract or agreement

- (i) with the Crown, or
 - (ii) with a public officer or department with respect to the Public Service of the Province, or
 - (iii) under which public money of the Province is to be paid for any service, work, matter or thing,
- (b) a shareholder or director in an incorporated company having a contract or agreement of the type specified in subclauses (i) to (iii) of clause (a), unless the contract or agreement is for the building of a public work for the Province,
- (c) proprietor of or otherwise interested in a newspaper or other periodic publication
- (i) in which are inserted from time to time official advertisements that appear in other newspapers or publications in the Province of Alberta, or
 - (ii) that is subscribed for by the Government of Alberta or any department thereof or by any of the public institutions of the Province,
- although the advertisements or subscriptions are paid for at the usual rates out of the public funds of the Province of Alberta, or
- (d) the purchaser or holder of any certificates or securities issued under *The Savings Certificates Act* or any other loan Act of the Province.

14. (1) A person is not incapable of being elected a member of the Legislative Assembly by reason of his being

- (a) a surety for a sheriff, registrar, clerk, bailiff or other public officer, or
- (b) a surety or contractor for the payment of the maintenance of a patient at a public asylum for the insane.

(2) Notwithstanding subsection (1), a person being at the time of his election a surety within the meaning of subsection (1) shall, before he sits or votes in the Legislative Assembly, take and complete such action as may be needed to relieve him from any liability thereafter accruing in respect of his suretyship, and until so doing he shall not sit or vote in the Legislative Assembly.

15. (1) Notwithstanding any other provision of this Act, a member of the Legislative Assembly serving on a commission or committee appointed either by the Legislative Assembly or by the Lieutenant Governor in Council or heretofore or hereafter serving as a delegate to any meeting of the Commonwealth Parliamentary Association, may be paid such sum of money for travelling expenses and subsistence in connection therewith as the Lieutenant Governor in Council deems proper, and the receipt of any such money does not render that member ineligible to be a member.

Eligibility of sureties of sheriffs, etc.

Receipt of money by member serving on committee

(2) Where no fixed amount has been provided for travelling and subsistence expenses of committees, commissions or delegates, the money shall only be paid to a member upon the member furnishing vouchers or such other evidence of payments made by him as is considered sufficient.

Receipt of compensation or pension

16. Notwithstanding any other provision of this Act, the receipt by a member of the Legislative Assembly of any compensation under *The M.L.A. Compensation Act* or any pension under *The Public Service Pension Act* does not render him ineligible to be a member of the Legislative Assembly.

Declaration of disqualification

17. (1) No disqualification under sections 10 or 11 on any ground arising before the election shall be held by any court to affect or to have hitherto affected the seat of a member of the Legislative Assembly, or to disentitle or to have disentitled a person to sit or vote therein, until such disqualification has been duly declared and found by an election court.

- (2) Subsection (1) shall not be construed as affecting
- (a) the cases mentioned in section 14 hereof, or
 - (b) the right of the Legislative Assembly to expel a member according to the practice of Parliament or otherwise.

Election of disqualified person invalid

18. (1) If a person who is by this Act disqualified or declared ineligible or incapable of being elected a member of the Legislative Assembly is nevertheless elected and returned as a member, his election and return are null and void.

Disqualification after election

(2) If a member of the Legislative Assembly by accepting an office or becoming a party to a contract or agreement as mentioned in section 11 becomes disqualified by law to sit or vote in the Legislative Assembly, his seat is thereby vacated, and a writ shall in the manner provided by this Act issue for a new election, but the disqualified member may be re-elected if he is not otherwise ineligible under this Act.

Penalty for voting after disqualification

19. (1) No person who is disqualified by this Act or by any other Act from being a member of the Legislative Assembly shall sit or vote in the Legislative Assembly while he is so disqualified.

(2) A person

- (a) who is by this Act made ineligible as a member of or declared incapable of sitting or voting in the Legislative Assembly, and
- (b) who sits or votes therein while he is so ineligible or incapable,

shall forfeit the sum of two hundred dollars for every day on which he so sits or votes.

Recovery of penalty

(3) The penalty specified in subsection (2) may be recovered by any person who sues for the same by action in any court of competent civil jurisdiction in Alberta.

(4) Where an action for the penalty specified in subsection (2) is brought and judgment in the action recovered against the defendant, no proceeding shall be had in any other action against the same person for any offence under this section and committed before the time of notice to him of the recovery of the judgment.

Proceedings after recovery of judgment

(5) While an action under the provisions of this section is pending and is being duly prosecuted in good faith no other action of the same nature shall be brought against the defendant.

Disclaimer

- 20.** A member elected to the Legislative Assembly
 - (a) may disclaim his seat in the manner hereinafter provided, and
 - (b) shall be held to have thereby vacated the seat and to have ceased to be a member of the Legislative Assembly in respect of the seat so disclaimed.

Disclaimer by member-elect

21. At any time after an election a member-elect who desires to disclaim

Form of disclaimer

- (a) may transmit through the post office by postpaid and registered mail directed to the Clerk of the Legislative Assembly at Edmonton, or
- (b) may cause to be delivered to such Clerk, a disclaimer signed by the member and to the effect following:

“I, A.B., member-elect to the Legislative Assembly of the Province of Alberta for the electoral division ofdo hereby disclaim all my right or title to sit or vote as such member or in any manner to act as such member.”

22. (1) The Clerk of the Legislative Assembly shall at the earliest practicable moment after he receives the disclaimer transmit or deliver a copy thereof to the Clerk of the Supreme Court for the judicial district in which is situated the electoral division, or the largest part of the electoral division, for which the person so disclaiming has been elected.

Transmission of disclaimer to Supreme Court

(2) The Clerk of the Court shall give notice of the disclaimer to any person who has filed or who thereafter presents to be filed a petition against the member so disclaiming.

Notice of disclaimer

- 23.** (1) A disclaimer does not affect
 - (a) the right of any person to contest the election and claim the seat for himself or some other person, and
 - (b) the liability of the disclaiming person for corrupt practices.

Effect of disclaimer on rights, etc.

Effect of disclaimer on petition

- (2) If a petition claims the seat for some other person
- (a) the judge or judges trying the case shall determine whether any candidate other than the member who has disclaimed was duly elected, and
 - (b) any other candidate declared by the judge or judges duly elected is entitled to take his seat.

Filing of petition when corruption charged

24. Notwithstanding anything in this Act and notwithstanding any disclaimer, a judge of the Supreme Court,

- (a) upon the application of a person entitled to vote at the election in question made within ten days after the Clerk of the Court has received notice of a disclaimer, and
- (b) if it is made to appear that there is good reason to believe that corruption has extensively prevailed at the election,

may permit a petition to be filed though no disclaimer had been made, or upon the grounds aforesaid may, upon such terms as he thinks fit, permit proceedings to continue upon any petition that has been filed.

Issue of new writ after disclaimer

25. Where no petition is filed within the time limited for that purpose by *The Controverted Elections Act*, or when the petition is dismissed, the Lieutenant Governor in Council may direct the issue of a new writ for the election of a member in the place of the disclaiming member and the writ shall issue accordingly.

Resignation of Seat

Resignation of seat

26. A member of the Legislative Assembly may resign his seat either

- (a) by declaring openly in his place in the Legislative Assembly his wish to resign his seat as a member, whereupon the Clerk of the Legislative Assembly shall record the wish in the journals and the seat forthwith becomes vacant, or
- (b) by causing to be delivered to the Speaker a resignation in writing under the member's hand, and attested by two witnesses, and upon the receipt of the resignation by the Speaker, whether during the session of the Legislative Assembly or not, the seat forthwith becomes vacant.

Resignation in absence of Speaker

27. (1) When a member of the Legislative Assembly wishes to resign his seat during or before any session or in the interval between two sessions of the Legislative Assembly and

- (a) there is then no Speaker, or
 - (b) the member is himself the Speaker,
- he may address and cause to be delivered to any two mem-

bers of the Legislative Assembly his resignation in writing under his hand and attested by two witnesses.

(2) The resignation may be in Form C in Schedule 2 to this Act, and upon the receipt of the resignation by the two members the seat forthwith becomes vacant.

Form of
resignation

28. Where a member executes a written form of resignation, the Speaker or the two members, as the case may be, upon receiving the resignation shall forthwith address his or their warrant under his or their hand and seal, or hands and seals, as in Form D in Schedule 2, to the Clerk of the Executive Council for the issue of a new writ for the election of a member in the place of the member who has resigned, and the writ shall issue accordingly.

29. (1) When a vacancy in the representation of any electoral division is created in any way other than by resignation, any two members of the Legislative Assembly may give notice of the vacancy to the Clerk of the Executive Council and require the issue of a writ to fill the vacancy.

(2) Notwithstanding subsection (1) when the vacancy occurs after a general election and before the first meeting of the Legislative Assembly thereafter, the notice and requisition to the Clerk of the Executive Council may be given by two members elect of the said Legislative Assembly of whose election the Clerk as such has had due notice.

(3) Every notice and requisition given under this section shall be submitted forthwith after its receipt by the Clerk to the Lieutenant Governor in Council and, upon its return by him to the Clerk endorsed as approved, the necessary proceedings shall be taken in pursuance thereof as in the case of a warrant under section 28.

30. No person shall be deemed to be a member of the Legislative Assembly so as to be entitled to resign under the provisions of this Act until notice of his election has been published in *The Alberta Gazette*.

Right of
resignation

31. The resignation of a member in no way affects the conduct or result of any proceedings that are pending or that may thereafter be taken under any law in force in the Province respecting controverted elections.

Speaker and Deputy Speaker

32. (1) The Legislative Assembly on its first assembling after a general election shall proceed with all practicable speed to elect one of its members to be Speaker.

Election of

Vacancy in office of Speaker	(2) Where a vacancy occurs in the office of Speaker by death, resignation or otherwise the Legislative Assembly shall proceed with all practicable speed to elect another of its members to be Speaker.
Speaker to preside	(3) Except as otherwise provided in this Act, the Speaker shall preside at all meetings of the Legislative Assembly.
Deputy Speaker	33. (1) The Legislative Assembly may elect a Deputy Speaker. (2) When the Speaker from illness or other cause finds it necessary to leave the chair during any part of the sittings of the House on any day, he may call upon the Deputy Speaker or in his absence upon any member of the Legislative Assembly to take the chair and act as Speaker during the remainder of the day unless the Speaker himself resumes the chair before the close of the sitting of that day. (3) The Deputy Speaker or the member so called upon shall take the chair and act as Speaker accordingly.
Validity of Acts when Deputy Speaker presides	(4) Every Act passed and every order made and thing done by the Legislative Assembly while the Deputy Speaker or a member is acting as Speaker as aforesaid is as valid and effectual as if the Speaker himself were presiding in the chair.
Procedure in absence of Speaker	34. (1) Whenever the Legislative Assembly is informed by the Clerk at the table of the unavoidable absence of the Speaker, the Deputy Speaker, if present, shall take the chair and shall perform the duties and exercise the authority of the Speaker in relation to all proceedings of the Legislative Assembly until the meeting of the Legislative Assembly on the next sitting day. (2) The Deputy Speaker shall so act from day to day on the like information being given to the Legislative Assembly until the Legislative Assembly otherwise orders.
Election of acting Speaker	35. (1) Whenever the Legislative Assembly is informed by the Clerk at the table of the unavoidable absence of both the Speaker and the Deputy Speaker the Legislative Assembly may elect a member to take the chair and act as Speaker for that day.
Validity of Acts when acting Speaker presides	(2) Every Act passed and every order made and thing done by the Legislative Assembly while a member is acting or presiding as Speaker pursuant to subsection (1) is as valid and effectual as if the Speaker himself were presiding in the chair.
Voting in Assembly	36. (1) Questions arising in the Legislative Assembly shall be decided by a majority of votes cast, and the Speaker or acting Speaker shall not vote.

(2) When the number of votes cast for and against a motion are equal the Speaker or acting Speaker has a vote but not otherwise. Voting by Speaker

37. (1) In respect of each session of the Legislative Assembly that is first held in any year there shall be paid to the Speaker and Deputy Speaker such allowances as are voted by the Legislative Assembly. Allowances payable to Speaker

(2) There shall be paid to the Speaker as an allowance in respect of each session of the Legislature held in any year after the first session the sum of twenty-five dollars in addition to any other allowance payable to him as the Speaker or as a member of the Legislative Assembly.

Powers and Privileges of the Legislative Assembly

38. The Legislative Assembly may at all times command and compel before it or before any committee of the Legislative Assembly Compelling attendance of persons, etc.

- (a) the attendance of such persons, and
 - (b) the production of such papers and things,
- as the Legislative Assembly or committee deems necessary in any of its proceedings or deliberations.

39. Whenever the Legislative Assembly requires the attendance of a person before the Legislative Assembly or before a committee thereof the Speaker may issue a warrant or subpoena Warrant for attendance

- (a) directed to the person named in the order of the Legislative Assembly, and
- (b) requiring his attendance and the production of such papers and things as may be ordered.

40. A standing or select committee of the Legislative Assembly Examination of witnesses by committee

- (a) may require the facts, matters and things relating to the subject of inquiry to be verified or ascertained by the oral examination of witnesses or otherwise, and
- (b) may examine the witnesses upon oath, and for that purpose the chairman or any other member of the committee may administer to a witness an oath or affirmation in Form A or Form B in Schedule 2.

41. (1) No person is liable in damages or otherwise for any act done Liability for acts done under warrant, etc.

- (a) under the authority of the Legislative Assembly and within its legal power, or

(b) under or by virtue of any warrant or subpoena issued under such authority.

Refusal to give aid
Infringement (2) All such warrants or subpoenas may command the aid and assistance of all sheriffs, constables and others and every refusal or failure to give such aid or assistance when required is an infringement of this Act.

Members protected from actions, etc. **42.** No member of the Legislative Assembly is liable to any civil action or prosecution, arrest, imprisonment or damages by reason of

(a) any matter or thing brought by him by petition, bill, resolution, motion or otherwise, or

(b) anything said by him, before the Legislative Assembly.

Members immune from arrest, etc., during session **43.** During a session of the Legislature, or the twenty days preceding and the twenty days following the session, no member of the Legislative Assembly is liable, except for a breach of this Act, to arrest, detention or molestation for any cause that is of a civil nature and within the legislative authority of the Province.

Members, etc. exempt from jury service **44.** During the periods mentioned in section 43

(a) all members, officers and employees of the Legislative Assembly, and

(b) all witnesses summoned to attend before the Legislative Assembly or a committee thereof, are exempt from serving or attending as jurors before any court of justice in the Province.

Judicial powers of Legislative Assembly **45.** (1) The Legislative Assembly is a court and has all the rights and privileges of a court for the purpose of summarily inquiring into and punishing the following:

(a) assaults, insults and libels upon the members of the Legislative Assembly while in session,

(b) obstructing, threatening or attempting to force or intimidate members of the Legislative Assembly,

(c) the offering to or acceptance by a member of the Legislative Assembly of

(i) a bribe to influence him in his conduct as a member, or

(ii) a fee, compensation or reward for or in respect of the promotion of any bill, resolution, matter or thing submitted to or intended to be submitted to the Legislative Assembly or a committee thereof,

(d) assaults upon or interference with an officer of the Legislative Assembly while in the execution of his duties,

- (e) tampering with a witness with regard to evidence to be given by him before the Legislative Assembly or a committee thereof,
- (f) presenting to the Legislative Assembly or a committee thereof any forged or falsified document with intent to deceive the Legislative Assembly or such committee,
- (g) the forging, falsifying or wrongfully altering of
 - (i) a record of the Legislative Assembly or of a committee thereof, or
 - (ii) a document presented or filed or intended to be presented or filed before the Legislative Assembly or committee,
- (h) the setting or subscribing by a person of the name of another person in or to such a document or petition as mentioned in clause (g) with intent to deceive,
- (i) the bringing of a civil action or prosecution against or the causing or effecting of the arrest or imprisonment of any member of the Legislative Assembly for or by reason of any matter or thing brought by him by petition, bill, resolution, motion or otherwise or said by him before the Legislative Assembly,
- (j) the causing or the effecting of the arrest, detention or molestation, during any session of the Legislative Assembly of any member of the Legislative Assembly for any cause whatever of a civil nature.

(2) For the purposes of this Act the Legislative Assembly possesses all the power and jurisdiction necessary or expedient

- (a) for inquiring into, judging and pronouncing upon the commission or doing of any of the acts, matters or things mentioned in subsection (1), and
- (b) for awarding and carrying into execution the punishment thereof as provided for by this Act.

46. Every person who, upon an inquiry under section 45, appears to have committed or done any of the acts, matters or things mentioned in subsection (1) of section 45, is, in addition to any other penalty that he may be subject to by law, liable to imprisonment for such time during the session of the Legislative Assembly then being held as the Legislative Assembly may determine.

Imprisonment of person committing certain offences

47. The determination of the Legislative Assembly upon any proceedings under this Act is final and conclusive.

Determination of Assembly final

48. When the Legislative Assembly declares that any person has been guilty of a contempt for any of the acts, matters and things mentioned in subsection (1) of section

Procedure when person contravenes section 45

45 and directs that he be taken into custody or be imprisoned, the Speaker shall issue his warrant

- (a) to the Sergeant-at-arms attending the Legislative Assembly,
- (b) to the keeper or governor of the common gaol in the City of Edmonton, or
- (c) to the officer commanding the Royal Canadian Mounted Police for the district in which the City of Edmonton is situated,

to take such person into custody and to keep and detain him in custody in accordance with the order of the Legislative Assembly made in that behalf.

49. In any civil proceedings or prosecution against a person for or on account of or in respect of the publication of any copy of any report, papers, votes or proceedings printed by or under the authority of the Legislative Assembly

- (a) the defendant at any stage of the proceedings may lay before the court or judge
 - (i) the report, papers, votes or proceedings and the copy,
 - (ii) an affidavit verifying the report, papers, votes or proceedings and the correctness of the copy,
 and
- (b) the court or judge shall immediately stay the civil proceedings and the same or every writ or process issued thereon shall be finally put an end to, determined and superseded by virtue of this Act.

50. (1) Upon the trial of an action against a person for printing an extract from or an abstract of any report, papers, notes or proceedings printed by or under the authority of the Legislative Assembly,

- (a) the report, papers, votes or proceedings may be given in evidence under the general issue or denial, and
- (b) it may be shown that the extract or abstract was published *bona fide* and without malice.

(2) If in the opinion of the court or jury the extract or abstract was published *bona fide* and without malice, judgment shall be rendered or a verdict shall be entered for the defendant.

Copy of
journals as

51. In the proceedings referred to in sections 49 and 50 a copy of the journals of the Legislative Assembly printed or purporting to be printed by its order shall be admitted as evidence of the journals and of their contents by all courts, justices and others without any proof being given that the copies were so printed.

Quorum and Manner of Voting

52. The presence of at least twenty members of the Legislative Assembly is necessary to constitute a meeting of the Legislative Assembly for the exercise of its powers, and in counting the number of those present the Speaker if present shall be included. Quorum of Assembly

Money Votes

53. The Legislative Assembly shall not originate or pass any vote, resolution, address or bill for the appropriation of Passage of appropriation bills, etc.

(a) any part of the General Revenue Fund, or

(b) any other tax or impost,

to a purpose that has not been first recommended by a message of the Lieutenant Governor to the Legislative Assembly during the session in which the vote, resolution, address or bill is proposed.

Indemnity to Members

54. (1) For each session of the Legislative Assembly that is first held in any year, a member of the Legislative Assembly attending the session is allowed and shall be paid Allowances payable to members

(a) a sessional indemnity allowance of two thousand four hundred dollars, and

(b) an expense allowance of one thousand two hundred dollars for expenses incidental to the discharge of the duties of a member of the Legislative Assembly.

(2) Notwithstanding the provisions of subsection (1), Deductions from allowances

(a) deductions shall be made at the rate of fourteen dollars per day from the sessional indemnity allowance, and at the rate of seven dollars per day from the expense allowance, for each day in excess of five days on which

(i) a sitting of the Legislative Assembly is held, and

(ii) the member does not attend the sitting or a meeting of some committee thereof, except where illness, which shall be certified by a qualified medical practitioner, is the cause of the absence,

(b) the total sessional allowances of a member who does not attend sittings of the Legislative Assembly or meetings of some committee thereof on at least one-half of the total number of sitting days in any session shall be for each day of attendance

(i) fourteen dollars per day as a sessional indemnity allowance, and

(ii) seven dollars per day as an expense allowance, except where illness, which shall be certified by a qualified medical practitioner, is the cause of the absence, or except in the cases provided for in section 56,

(c) where illness is the cause of the absence of a member from a sitting of the Legislative Assembly or a meeting of some committee thereof, and the illness is certified by a qualified medical practitioner, then for the purposes of clauses (a) and (b), the member shall be deemed in computing his sessional indemnity allowance and his expense allowance to have been present during each day of his illness.

Allowances payable when extra sessions held

(3) For each session of the Legislative Assembly that is in any year held after the first session held in that year a member of the Legislative Assembly attending the session is allowed and shall be paid

(a) a sessional indemnity allowance of fourteen dollars a day, and

(b) an expense allowance of seven dollars a day for any period, not in excess of ten days, during which the member attends the sittings of that session of the Legislative Assembly or the meetings of any committee thereof.

(4) Subsection (3) does not apply to members of the Legislative Assembly who are members of the Executive Council.

Compensation of Executive Council members

(5) The annual compensation to be paid

(a) to the President of the Executive Council shall be eleven thousand dollars, and

(b) to each other member of the Executive Council shall be eight thousand five hundred dollars.

Allowances to leader of opposition

(6) In each year there shall be paid to the recognized leader of Her Majesty's loyal opposition such allowance as may be voted by the Legislative Assembly..

Time of payment of allowances

55. (1) The allowances may from time to time as the member becomes entitled to them be paid to the extent of

(a) fourteen dollars a day on account of the sessional indemnity allowance, and

(b) seven dollars a day on account of the expense allowance,

for each day's attendance at the Legislative Assembly or at a committee of the Legislative Assembly.

(2) The remainder of the allowances shall be retained by the Provincial Treasurer until the close of the session when the final payment shall be made, except that where

after sitting the Legislative Assembly adjourns the remainder less the sum of one hundred dollars shall be paid at the time of the adjournment.

56. If a member is elected and takes his seat in the Legislative Assembly after the commencement of the session or if during the session a member ceases to be a member, he is entitled to the regular sessional allowances, subject to a deduction of fourteen dollars from the sessional indemnity allowance and of seven dollars from the expense allowance for each day of the session before taking his seat or after he ceased to be a member or both, as the case may be.

Allowances payable for part of session

57. A member of the Legislative Assembly is allowed

- (a) five cents for each mile of the distance between the railway station nearest to the place of his residence and the place at which the session is held but the distance both going and coming shall be calculated according to the shortest railway route, and
- (b) his actual travelling expenses between his place of residence and the railway station if the distance is greater than five miles.

Travelling allowance

58. The sum due to every member of the Legislative Assembly at the close of a session shall be calculated and paid to him on his making and signing before the Clerk of the Legislative Assembly or a justice of the peace a solemn declaration, which shall be kept by the Provincial Treasurer, showing

Payment of amount due to member

- (a) the number of days the member attended the session,
- (b) the number of days, if any, for which a deduction from the amount of the allowance of the member has to be made under any preceding section of this Act, and
- (c) the amount of the actual travelling expenses of the member as determined and certified by the Speaker.

Legislative Counsel

59. The Lieutenant Governor in Council

- (a) may appoint as Legislative Counsel a barrister of at least five years' standing, and
- (b) may fix the remuneration of the Legislative Counsel and prescribe his duties.

Appointment of Legislative Counsel

60. The Legislative Counsel

- (a) shall prepare the legislation entrusted to him,

Duties of Legislative Counsel

- (b) shall collect, summarize and index information relative to the legislation passed by the Imperial Parliament, the Parliament of Canada, and the Legislative Assemblies of the various provinces and foreign countries,
- (c) is the revisor of statutes and shall continually keep the statutes of the Province in a consolidated form by means of loose-leaf books, or such other means as are thought advisable,
- (d) shall prepare such a consolidation and revision of the statutes and other matters relating to statutes as is from time to time directed by the Attorney General, and shall present the consolidation, revision or other matter to the Executive Council for its decision on the question of submitting it to the Legislative Assembly, and
- (e) shall perform such other duties of a like nature as the Attorney General or the Lieutenant Governor in Council directs.

Status of

61. Under this Act, women

- (a) are upon an absolute equality with men,
- (b) have the same rights and privileges as men, and
- (c) are subject to the same penalties and disabilities as men.

Repeal

62. *The Legislative Assembly Act*, being chapter 4 of the Revised Statutes of Alberta, 1942, is hereby repealed.
