

Bill No. 38 of 1955

A BILL TO AMEND THE MUNICIPAL HOSPITALS ACT

---

NOTE

This Bill amends *The Municipal Hospitals Act* being chapter 185 of the Revised Statutes of Alberta, 1942.

*The Municipal Hospitals Act* is being used in areas of the Banff National Park to provide municipal hospital districts. It is therefore necessary to make some changes in this Act to refer particularly to such an area.

Section 2, clauses (b) and (l) are amended to have the definition of "contributing council" and "ratepayer", respectively, apply in National Park areas.

Section 3, subsection (2) is amended to bring a reference up to date.

Section 11, subsection (5) is amended to refer to a hospitalization agreement which may be made under *The Hospitalization and Treatment Services Act*. The provisions here referred to were originally in *The Hospitals Act* only, but are now divided between these two Acts.

Section 68, subsection (3) is amended to correct a reference.

The Schedule is amended for the same purpose.

This Bill comes into force upon assent.

# BILL

An Act to amend The Municipal Hospitals Act

**H**ER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. *The Municipal Hospitals Act*, being chapter 185 of the Revised Statutes of Alberta, 1942, is hereby amended.

2. Section 2 is amended

(a) by striking out clause (b) and by substituting the following:

"contributing  
council"

"(b) 'contributing council' means

"(i) a council administering an included area,

"(ii) in respect of an improvement district or special area, the Minister of Municipal Affairs, and

"(iii) in respect of a national park area, the Park Superintendent;";

(b) by striking out clause (l) and by substituting the following:

"ratepayer"

"(l) 'ratepayer' means

"(i) any person liable to pay municipal or improvement district taxes on property situate within the district, and

"(ii) in respect of a municipal hospital district within a national park area, any person who pays a property tax for municipal or school purposes;";

3. Section 3, subsection (2) is amended by striking out the figures "1947" and by substituting the figures "1954".

Section 11  
amended

4. Section 11, subsection (5) is amended by adding immediately after the word "Act" the words "or made pursuant to *The Hospitalization and Treatment Services Act* or the regulations thereunder".

Section 68  
amended

5. Section 68, subsection (3) is amended by adding immediately after the words "*The Public Service Act*," the figures "1954,".

- 6.** The Schedule is amended as to the reference Section Schedule amended  
2 (j) immediately preceding Form A
- (a) by adding immediately after the words "*The Town and Village Act*" the figures ", 1952",
  - (b) by adding immediately after the words "*The Municipal District Act*" the figures ", 1954",
  - (c) by adding immediately after the words "*The Improvement Districts Act*" the figures ", 1947".
- 7.** This Act comes into force on the day upon which Coming into force  
it is assented to.
