

Bill No. 81 of 1955

A BILL TO AMEND THE BILLS OF SALE ACT

NOTE

This Bill amends *The Bills of Sale Act*, being chapter 217 of the Revised Statutes of Alberta, 1942.

Section 13, subsection (1) is amended to correct a misprint. The other amendments to the Act are necessitated by the 1951 amendments to the Act, which introduced a different system for the registration of bills of sale relating to motor vehicles, aircraft, trailers or oil well drilling equipment. The present amendments are to clarify the provisions in the Act relating to registration in view of the 1951 amendments.

This Bill comes into force upon assent except that the amendments to section 11, relating to the renewal of the registration of bills of sale are retroactive to the 30th day of June, 1954, the day on which the period of three years after the coming into force of the 1951 amendments expires.

An Act to amend The Bills of Sale Act

(Assented to _____, 1955)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. *The Bills of Sale Act*, being chapter 217 of the Revised Statutes of Alberta, 1942, is hereby amended.

Section 6
amended

2. Section 6 is amended

- (a) as to subsection (1) by adding immediately after the words "shall be effected" the words ", subject to sections 10a and 10b,"
- (b) as to subsection (2) by adding immediately after the words "may be effected" the words ", subject to sections 10a and 10b,"

Section 11
amended

3. Section 11 is amended

- (a) as to subsection (1) by striking out the words and figures "subsection (2) and (3)" and by substituting the words and figures "subsections (2), (3) and (3a)",
- (b) as to subsection (3) by striking out the words "The renewal" and by substituting the words "As regards chattels included in the bill of sale other than any motor vehicle, aircraft, trailer or oil well drilling equipment, the renewal",
- (c) by adding immediately after subsection (3) the following new subsection:
 - "(3a) As regards any motor vehicle, aircraft, trailer or oil well drilling equipment included in the bill of sale, the renewal statement accompanied by the affidavit or duplicate originals or true copies thereof, shall be registered in the office of the registration clerk in the Motor Vehicle Branch."
- (d) as to subsection (4) by striking out the word and figure "and (3)" and by substituting the word and figures ", (3) and (3a)".

Section 12
amended

4. Section 12 is amended by adding immediately after the words "comprised therein" the words ", other than any motor vehicle, aircraft, trailer or oil well drilling equipment,".

5. Section 13, subsection (1) is amended by striking out the words "of the affidavit by" and by substituting the words "by the affidavit of". Section 13
amended

6. Section 15, subsection (3) is amended by adding immediately after the words "so assigned" the words ", being chattels other than any motor vehicle, aircraft, trailer or oil well drilling equipment,". Section 15
amended

7. Section 16, subsection (3) is amended by adding immediately after the words "affected by the discharge" the words ", being chattels other than any motor vehicle, aircraft, trailer or oil well drilling equipment,". Section 16
amended

8. This Act comes into force on the day upon which it is assented to and upon so coming into force section 3 shall be deemed to have been in force at all times on and after the thirtieth day of June, 1954. Coming into
