# BILL 5

A Bill to amend The Agrologists Act

HON. MR. HALMRAST

## **Explanatory Note**

2. The amendment is for the purpose of enabling graduates in agriculture from recognized universities who are actively engaged in farming to become members of the Alberta Institute of Agrologists, which was heretofore restricted to graduates who were employed in teaching or in other capacities.

3. Section 20 presently reads as follows:

"20. Any graduate in agriculture from the University of Alberta or other college or university recognized by the General Faculty Council, may apply to be registered as an agrologist in training and, on payment of such a registration fee and subsequent annual fees as may be determined by the by-laws of the institute, he may be allowed to practise agrology under the guidance of an agrologist."

This amendment will enable agrologists in training to practise agrology without the guidance of a member of the institute.

4. Form A is amended to remove reference to the terms "practice of agrology" and "practise agrology", as these are defined terms that do not include farming operations.

## An Act to amend The Agrologists Act

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

#### PART I

- 1. The Agrologists Act, being chapter 19 of the Statutes of Alberta, 1947, is hereby amended.
- **2.** Section 19 is amended by adding immediately after clause (d) the following:
  - "(e) a bona fide resident of the Province who
    - "(i) has obtained from the University of Alberta, or from a university or college recognized by the General Faculty Council, a degree in agriculture or any degree deemed by the General Faculty Council to be the equivalent of a degree in agriculture, and
    - "(ii) has been actively engaged in farming operations and in the practice of agrology or either for a period of at least three years following graduation.".
- 3. Section 20 is amended by striking out the words "under the guidance of an agrologist".

4. Form A is amended by striking out the words "regarding the practice of agrology and has been adjudged qualified to practise agrology," and by substituting the words "in that behalf and who has been adjudged qualified,".

This Part relates the amendments of this session to the revision and consolidation.

#### PART II

- 5. The Agrologists Act, being chapter 11 of the Revised Statutes of Alberta, 1955, is hereby amended.
- **6.** Section 20 is amended by adding immediately after clause (d) the following:
  - "(e) a bona fide resident of the Province who
    - "(i) has obtained from the University of Alberta, or from a university or college recognized by the General Faculty Council, a degree in agriculture or any degree deemed by the General Faculty Council to be the equivalent of a degree in agriculture, and
    - "(ii) is actually engaged in farming operations,".
- 7. Section 21 is amended by striking out the words "under the guidance of an agrologist".
- 8. Form A in the Schedule is amended by striking out the words "regarding the practice of agrology and has been adjudged qualified to practise agrology," and by substituting the words "in that behalf and who has been adjudged qualified,".
- 9. Part I and this section come into force on the day this Act is assented to, and Part II, except this section, comes into force and Part I is repealed on the day the Revised Statutes of Alberta, 1955, come into force.
