Explanatory Note

2. Section 5 now reads:

"5. The Minister, with the approval of the Lieutenant Governor in Council, may appoint an advisory committee which shall advise and assist the Minister or the Cabinet Committee."

The new section will permit the appointment of a chairman of Civil Defence for Alberta; will enable an advisory committee to be appointed to assist him as well as such committees to assist the Minister and Cabinet Committee; and expressly empowers the Lieutenant Governor in Council to allocate the accounting services required under this Act to the Department best suited to handle them.

3. Part II will relate the amendment to the revision.

An Act to amend The Civil Defence and Disaster Act

(Assented to _____, 1956)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

PART I

1. *The Civil Defence and Disaster Act*, being chapter 10 of the Statutes of Alberta, 1951, is hereby amended.

2. Section 5 is struck out and the following is substituted:

"5. (1) The Lieutenant Governor in Council may from time to time appoint a chairman of Civil Defence for the Province whose duties shall be such and who shall receive such travelling and other allowances as may be prescribed from time to time by the Lieutenant Governor in Council.

"(2) With the approval of the Lieutenant Governor in Council, the Minister may from time to time appoint advisory committees to assist the Minister, Cabinet Committee and chairman of Civil Defence.

"(3) The Lieutenant Governor in Council may by regulations allocate to one or more Departments the performance of the accounting services required in the administration of this Act."

PART II

3. *The Civil Defence and Disaster Act*, being chapter 43 of the Revised Statutes of Alberta, 1955, is hereby amended.

4. Section 5 is struck out and the following is substituted:

"5. (1) The Lieutenant Governor in Council may from time to time appoint a chairman of Civil Defence for the Province whose duties shall be such and who shall receive such travelling and other allowances as may be prescribed from time to time by the Lieutenant Governor in Council.

"(2) With the approval of the Lieutenant Governor in Council, the Minister may from time to time appoint advisory committees to assist the Minister, Cabinet Committee and chairman of Civil Defence.

"(3) The Lieutenant Governor in Council may by regulations allocate to one or more Departments the performance of the accounting services required in the administration of this Act."

5. Part I and this section come into force on the day this Act is assented to, and Part II, except this section, comes into force and Part I is repealed on the day the Revised Statutes of Alberta, 1955, come into force.
