A Bill to amend An Act to incorporate the Highwood
Western Railway Company, being chapter 74 of
the Statutes of Alberta, 1946

Explanatory Note

Section 14 of the Act presently reads:

"14. The construction of the railway hereby authorized shall be commenced within two years and shall be completed within five years from the 31st day of March, 1954, and section 70, of The Railway Act, being chapter 197 of the Revised Statutes of Alberta, 1942, shall not apply to the Company."

Section 70 of The Railway Act reads:

"70. If the railway authorized by the special Act to be constructed is of a length not greater than thirty miles the company shall construct and put the same in operation within two years from the date of its incorporation; if however the railway is of greater length than thirty miles the company shall in addition to the thirty miles which it is hereby required to construct and put in operation within two years from its date of incorporation, construct and put in operation at least thirty miles during each year immediately following the expiration of the said two years and shall complete the whole railway within five years from the date of incorporation and should the company fail to comply with the provisions of this section then the power granted by the special Act or by this Act shall cease and be null and void as respects so much of the railway as then remains uncompleted."

1. *An Act to incorporate the Highwood Western Railway Company*, being chapter 74 of the Statutes of Alberta, 1946, is hereby amended.

2. Section 14 is struck out and the following substituted therefor:
