Preamble

WHEREAS the Young Men's Christian Association of Edmonton has prayed for an amendment to chapter 40 of the Statutes of Alberta, 1907, being "An Act respecting the Young Men's Christian Association of Edmonton" and it is expedient to grant the prayer of the said petition:

THEREFORE, HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. An Act respecting the Young Men's Christian Association of Edmonton, being chapter 40 of the Statutes of Alberta, 1907, is hereby amended.

Albert Freeman Ewing, or such other persons as are now or shall hereafter become members of the said association, shall be and they are hereby constituted a body politic and corporate under the name of "The Young Men's Christian Association of Edmonton", and shall have power to acquire and hold real estate in the (Province of Alberta), or any lease-hold or other interest therein, providing the annual value of the real estate so acquired or held and not actually used for the work of the said association, does not exceed at any one time \$10,000.00, and the same, or any part thereof, to alienate, exchange, mortgage, lease or otherwise charge or dispose of as occsion may require.

3. This Act comes into force on the day upon which it  $\frac{\text{Coming}}{\text{into force}}$  is assented to.
