# BILL

No. 7 of 1957

An Act to Exempt from Taxation the Real and Personal Property of The Mennonite Conference of Alberta used by it for the site of a Home for the Aged and Infirm at Coaldale, Alberta

(Assented to , 1957)

WHEREAS there exists an Association known as The Mennonite Conference of Alberta, incorporated under *The Religious Societies Lands Act* of the Province of Alberta on the 11th day of October, A.D. 1952; and

Whereas the said Mennonite Conference of Alberta operates a home for the aged and infirm at Coaldale, Alberta, on a non-profit basis; and

Whereas a Petition presented by the said Mennonite Conference of Alberta prays that an Act be passed by the Legislature of the Province to enact as hereinafter set forth, with regard to the exemption from taxation of that part of the Association's property used by it in the operation of the said home for the aged and infirm; and

Whereas it is expedient to grant the prayer of the said Petition;

Therefore Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. All the real and personal property described as and situate on:

Lot Five (5) in Block One (1) according to a Plan of Record in the Land Titles Office for the South Alberta Land Registration District as "Coaldale 1961 E.M." Excepting thereout Thirty-five Thousandths (0.035) of an acre, more or less, for a Roadway as shown on a Plan filed in the said Land Titles Office as 2559 E.Z. subject to the right of expropriation of certain portions thereof and to such other rights and conditions as are set forth in transfer registered as 6261 B.S., and also excepting thereout all mines and minerals.

while used as a home for the aged and infirm shall as and from the first day of January, A.D. 1957, be exempt from all taxes, rates, levies and assessments of every nature and kind, save and except special frontage assessment taxes under *The Town and Village Act, 1952*.

2. This Act comes into force on the day upon which it is assented to.
