## Explanatory Note

2. This amendment is for the purpose of increasing the penalties for unlicensed livestock dealings. Section 5, subsection (6) presently reads as follows:

“(6) A person who at a time when he is not the holder of a valid and subsisting licence authorizing him to do so, deals in any livestock or livestock products for the dealing in which he is required to be licensed pursuant to this Act, is guilty of an offence and liable on summary conviction, where the offender is a body corporate to a fine of not more than two hundred dollars, and in any other case to a fine of not more than fifty dollars and in default of payment to imprisonment for a term of not more than ninety days.”

An Act to amend The Alberta Livestock and Livestock

**H**ER MAJESTY, by and with the advice and consent of  
the Legislative Assembly of the Province of Alberta,  
enacts as follows:

**1.** *The Alberta Livestock and Livestock Products Act*,  
being chapter 181 of the Revised Statutes of Alberta, 1955,  
is hereby amended.

**2.** Section 5 is amended by striking out subsection (6)  
and by substituting the following:

“(6) A person who, at a time when he is not the holder  
of a valid and subsisting licence authorizing him to do so,  
deals in any livestock or livestock products for the dealing  
in which he is required to be licensed pursuant to this Act,  
is guilty of an offence and liable on summary conviction,

“(a) when the offender is a body corporate, to a fine of  
not more than two hundred dollars for a first of-  
fence and not less than two hundred dollars or  
more than five hundred dollars for a second or sub-  
sequent offence, and

“(b) when the offender is not a body corporate, to a  
fine of not more than fifty dollars for a first of-  
fence and not less than fifty dollars or more than  
two hundred dollars for a second or subsequent  
offence, and in default of payment to imprison-  
ment for a term not exceeding three months.

“(6a) A person who, at a time when his licence to do  
so is under suspension or has been cancelled, deals in any  
livestock or livestock products for the dealing in which he  
is required to be licensed pursuant to this Act, is guilty  
of an offence and liable on summary conviction

“(a) when the offender is a body corporate, to a fine of  
not more than four hundred dollars for a first of-  
fence, and not less than four hundred dollars or  
more than one thousand dollars for a second or  
subsequent offence, and

“(b) when the offender is not a body corporate, to a  
fine of not more than one hundred dollars for a  
first offence and not less than one hundred dollars  
or more than four hundred dollars for a second or

**3. Section 17 presently reads:**

“17. A person contravening a provision of this Act or of a regulation is guilty of an offence and liable on summary conviction where no other penalty is prescribed to a fine of not more than five hundred dollars or to imprisonment for a term not exceeding three months.”

**4. Amendments to come into force with the Revised Statutes of 1955.**

subsequent offence, and in default of payment to imprisonment for a term not exceeding three months.”.

**3.** Section 17 is amended by striking out the words “five hundred” and by substituting the words “one thousand”.

**4.** This Act comes into force on the day upon which the Revised Statutes of Alberta, 1955, come into force.
