2. Section 3 presently reads as follows:

 $^{\prime\prime} \textbf{3.}$ (1) The provisions of this Act authorizing the consolidation of arrears of taxes are in force in

"(a) all improvement districts,

"(a) all improvement districts,
"(b) such municipalities other than improvement districts as have in any year passed a by-law in such form as the Minister may prescribe, from time to time, and declaring that during the year in which the by-law is passed arrears of taxes may be consolidated pursuant to the provisions of this Act, and
"(c) those towns, villages and municipal districts to which the provisions of this Act authorizing the consolidation of arrears of taxes are applied under subsection (3).
"(2) No by-law passed under this section has any effect until it has been submitted to and approved by the Minister in writing.
"(3) If the council of a town, village, county or municipal district

"(3) If the council of a town, village, county or municipal district declines to pass a by-law pursuant to this section in any year, and the Minister is satisfied that it is reasonable, convenient and proper to do so, he may from time to time declare by written order that the provisions of this Act authorizing the consolidation of arrears of taxes are in force in any town, village, county or municipal district named in the order during the year in which the order is made."

The amendment to subsection (1) makes the use of a standard by-law unnecessary.

 \mathbf{H}^{ER} MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. The Local Tax Arrears Consolidation Act, being chapter 185 of the Revised Statutes of Alberta, 1955, is hereby amended.

2. Section 3 is amended

- (a) as to clause (b) of subsection (1) by striking out the words "in such form as the Minister may prescribe, from time to time, and",
- (b) by striking out subsections (2) and (3).

3. This Act comes into force on the day upon which the Revised Statutes of Alberta, 1955, come into force.
