A Bill to amend The Alberta Pharmaceutical Association Act

Explanatory Note

- 2. Section 2 clause (d) reads as follows:

 - "(d) "drug store" or "pharmacy" means a place where prescriptions, drugs, chemicals and poisons are sold by retail or compounded.".

Some establishments confine themselves exclusively to dispensing prescriptions. The word "dispensary" is used elsewhere in the Act but was not previously defined.

- 3. Section 5 states the requirements for eligibility for the governing council. Subsection (4) presently reads:
 - "(4) The term of office of a councillor is two years, but the office of councillor shall be vacated if the councillor "(a) by notice in writing to the president or registrar of the Association resigns his office,

 "(b) ceases to reside in the district of the Province that he was elected to represent,

 - "(c) ceases to be actively engaged in practising his profession of pharmacy,
 - "(d) ceases to be a member of the Association, or
 - "(e) dies, or is found to be a lunatic or becomes of unsound mind.".

This amendment would permit a councillor to retain his office when he moves to another part of the Province.

4. This new section will permit qualified pharmacists in the Armed Forces to practise while in Alberta.

An Act to amend The Alberta Pharmaceutical Association
Act

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

- 1. The Alberta Pharmaceutical Association Act, being chapter 232 of the Revised Statutes of Alberta, 1955, is hereby amended.
- **2.** Section 2, clause (d) is amended by adding immediately after the word "pharmacy" the words "or "dispensary"".
- **3.** Section 5, subsection (4) is amended by striking out clause (b).

- **4.** The following new section is added immediately after section 29:
- "29a. (1) The registrar shall register for a period not exceeding twelve months a candidate who
 - "(a) applies in person,
 - "(b) produces evidence satisfactory to the registrar
 - "(i) that he is a member of the Canadian Forces on full-time service,
 - "(ii) that his duties in the Canadian Forces require him to be registered as a pharmaceutical chemist in Alberta,
 - "(iii) that he meets the requirements of clause (d) of section 29,

5. Subsections (2) and (3) presently read as follows:

"(2) Notwithstanding subsection (1), nothing contained in this section prevents any person selling poisons, drugs or medicine at any point in the Province more than fifteen miles from the nearest place of business operated by a member of the Association, and all other provisions of this Act in regard to the sale of poisons apply to any sale by any such person.

"(3) A person who is not registered under this Act and the holder of a valid and subsisting certificate of registration shall not dispense any prescription, recipe or formula or compound any drugs or medicines unless the dispensary, pharmacy, drug store, hospital dispensary or place of business is in charge and under the supervision of a person who is registered under this Act.

The amendment prohibits unqualified persons from dispensing prescriptions.

Section 36 requires that manufacturing processes have to be under the supervision of a pharmacist. It is not necessary for all employees engaged in the actual manufacturing processes to have pharmaceutical qualifications.

- "(c) proves he is a registered member of a pharmaceutical association or society, or college of pharmacy in Canada, and
- "(d) pays the prescribed fee.
- "(2) A person who is registered under this section may apply, either after or immediately before his registration expires, to be registered for a further period.
- "(3) Every application for registration for a further period shall be deemed a new application.
- "(4) The registrar shall remove from the register the name of any person registered under this section when
 - "(a) the period for which that person was registered expires,
 - "(b) the person ceases to be a member of the Armed Forces on full-time service.
- "(5) A person is, while he is registered under this section, a pharmaceutical chemist within the meaning of this Act.".
- **5.** Section 31 is amended by striking out subsections (3) and (4) and by substituting the following:
 - "(3) No person other than
 - "(a) a pharmaceutical chemist, or
 - "(b) a pharmaceutical interne when under the immediate personal supervision and in the presence of a pharmaceutical chemist

shall dispense any prescription, recipe or formula, or compound any drug or medicine.

- "(4) No person shall employ any person other than
- "(a) a pharmaceutical chemist, or
- "(b) a pharmaceutical interne when under the immediate personal supervision and in the presence of a pharmaceutical chemist

to dispense any prescription, recipe or formula, or compound any drug or medicine.

- "(4a) Subsections (3) and (4) do not apply to the manufacturing of drugs under the provisions of section 36.".
- 6. This Act comes into force on the day upon which the Revised Statutes of Alberta, 1955, come into force.
