An Act to amend The Legislative Assembly Act (2)

, 1957)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

- 1. The Legislative Assembly Act, being chapter 174 of the Revised Statutes of Alberta, 1955, is hereby amended.
- 2. Section 2 is amended by striking out the word "sixty-one" and by substituting the word "sixty-five".
- 3. Section 3 is struck out and the following substituted:
 "3. Each of the electoral divisions mentioned and defined in Schedule 1 to this Act is entitled to return one member.".
 - 4. Schedule 1 is amended
 - (a) by striking out the legal description of the Electoral Division of Calgary and by substituting the following:

"Electoral Division of Calgary Bowness, the boundary whereof is as follows: Commencing at the north-east corner of section 8, township 25, range 1, west of the fifth meridian; thence southerly along the east boundaries of sections 8 and 5 in the said township and along the west limit of Fourteenth Street North West in the City of Calgary to the left bank of the Bow River; thence in a generally westerly direction along the said left bank to the east boundary of the west half of section 24, township 24, range 2, west of the fifth meridian; thence southerly along the east boundaries of the west halves of sections 24 and 13 in township 24, range 2, west of the fifth meridian, to the centre line of the Old Banff Coach Road as shown on a plan of record in the Land Titles Office for the South Alberta Land Registration District as Road Plan 1288 I; thence in a generally westerly direction along the said centre line to the meridian between ranges 2 and 3, west of the fifth meridian; thence northerly along the meridian between ranges 2 and 3, west of the fifth meridian to the north-east corner of section 12, township 25, range 3, west of the fifth meridian; thence easterly along the north boundaries of sections 7 to 12 inclusive, township 25, range 2, west of the fifth meridian, and of sections 7 and 8, township 25, range 1, west of the fifth meridian to the point of commencement.

"Electoral Division of Calgary North, the boundary whereof is as follows: Commencing at the intersection of the centre line of Centre Street in the City of Calgary with the left bank of the Bow River; thence in a generally westerly direction along the said left bank to the west limit of Fourteenth Street North West in the City of Calgary; thence northerly along the west limit of Fourteenth Street North West and of the road allowance east of sections 5 and 8 in township 25, range 1, west of the fifth meridian; thence easterly along the north boundaries of sections 9 and 10 in the said township; thence southerly along the east boundaries of sections 10 and 3 in the said township; thence westerly along the north boundary of section 34, township 24, range 1, west of the fifth meridian to the centre line of Centre Street aforesaid; thence southerly along the centre line of Centre Street to the point of commencement.

"Electoral Division of Calgary North East, the boundary whereof is as follows: Commencing at the north east corner of section 10, township 25, range 29, west of the fourth meridian; thence westerly along the north boundaries of sections 10 and 9 in the said township and of sections 12 and 11, township 25, range 1, west of the fifth meridian; thence southerly along the east boundaries of sections 10 and 3, township 25, range 1, west of the fifth meridian; thence westerly along the north boundary of section 34, township 24, range 1, west of the fifth meridian to the centre line of Centre Street in the City of Calgary; thence southerly along the centre line of Centre Street to the left bank of the Bow River; thence easterly and southerly along the said left bank to the north boundary of section 12, township 24, range 1, west of the fifth meridian; thence easterly along the north boundary of section 12, township 24, range 1, west of the fifth meridian, and along the north boundaries of sections 9 and 10, township 24, range 29, west of the fourth meridian; thence northerly along the east boundaries of sections 15, 22, 27 and 34, township 24, range 29, west of the fourth meridian, and of sections 3 and 10, township 25, range 29, west of the fourth meridian, to the point of commencement.

"Electoral Division of Calgary Centre, the boundary whereof is as follows: Commencing at the intersection of the centre lines of Centre Street and Seventeenth Avenue South West in the City of Calgary; thence westerly along the said centre line of Seventeenth Avenue South West to the production southerly of the east boundary of the west half of section 13, township 24, range 2, west of the fifth meridian; thence northerly along the said production and along the east boundaries of the west halves of sections 13 and 24 in the said township to the left bank of the Bow River; thence in a generally easterly direction along the said left bank to the centre line of Centre Street aforesaid; thence southerly along the centre line of Centre Street to the point of commencement.

"Electoral Division of Calgary West, the boundary whereof is as follows: Commencing at the intersection of the centre lines of Fourteenth Street West and Seventeenth Avenue South West in the City of Calgary; thence westerly along the said centre line of Seventeenth Avenue South West to the production southerly of the east boundary of the west half of section 13, township 24, range 2, west of the fifth meridian; thence northerly along the said production and said east boundary to the centre line of the Old Banff Coach Road as shown on a plan of record in the Land Titles Office for the South Alberta Land Registration District as Road Plan 1288 I; thence in a generally westerly direction along the said centre line of the Old Banff Coach Road to the meridian between ranges 2 and 3, west of the fifth meridian; thence southerly along the said meridian between ranges 2 and 3 to the left bank of the Elbow River; thence south-easterly downstream along the said left bank to the meridian between ranges 1 and 2, west of the fifth meridian; thence northerly along the said meridian between ranges 1 and 2 to the north-east corner of section 36, township 23, range 2, west of the fifth meridian; thence easterly along the north boundary of section 31, township 23, range 1, west of the fifth meridian, to the centre line of Twenty-fourth Street West in the City of Calgary; thence northerly along the said centre line of Twenty-fourth Street West to the centre line of Thirty-fourth Avenue South West in the said city; thence easterly along the said centre line of Thirtyfourtn Avenue South West to the centre line of Fourteenth Street West in the said city; thence northerly along the said centre line of Fourteenth Street West to the point of commencement.

"Electoral Division of Calgary Glenmore, the boundary whereof is as follows: Commencing at the intersection of the centre lines of Seventeenth Avenue South West and Centre Street in the City of Calgary; thence southerly along the centre line of Centre Street to the left bank of the Elbow River; thence in a generally south-westerly direction along the said left bank to its most southerly intersection with the centre line of Fourth Street West in the City of Calgary; thence southerly along the centre line of Fourth Street West and of the road allowance east of section 28, township 23, range 1, west of the fifth meridian; thence westerly along the north boundaries of sections 21 and 20 and the north-east quarter of section 19 in the said township to the left bank of the Elbow River; thence in a generally westerly direction along the said left bank to the meridian between ranges 1 and 2, west of the fifth meridian; thence northerly along the said meridian between ranges 1 and 2 to the north-east corner of section 36, township 23, range 2, west of the fifth meridian; thence easterly along the north boundary of section 31, township 23, range 1, west of the fifth meridian, to the centre line of Twenty-fourth Street West in the City of Calgary; thence northerly along the said centre line of Twentyfourth Street West to the centre line of Thirtyfourth Avenue South West in the said city; thence easterly along the said centre line of Thirty-fourth Avenue South West to the centre line of Fourteenth Street West in the said city; thence northerly along the said centre line of Fourteenth Street West to the centre line of Seventeenth Avenue South West aforesaid; thence easterly along the centre line of Seventeenth Avenue South West to the point of commencement.

"Electorial Division of Calgary South East the boundary whereof is as follows: Commencing at the north-east corner of section 10, township 24, range 29, west of the fourth meridian; thence westerly along the north boundaries of sections 10 and 9 in the said township and of section 12, township 24, range 1, west of the fifth meridian, to the left bank of the Bow River; thence northerly and westerly along the said left bank to the centre line of Centre

Street in the City of Calgary; thence southerly along the centre line of Centre Street to the left bank of the Elbow River; thence in a generally south-westerly direction along the left bank of the Elbow River to its most southerly intersection with the centre line of Fourth Street West in the said city; thence southerly along the centre line of Fourth Street West and of the road allowance east of section 28, township 23, range 1, west of the fifth meridian; thence easterly along the north boundaries of sections 22, 23 and 24, township 23, range 1, west of the fifth meridian, and of sections 21 and 22, township 23, range 29, west of the fourth meridian; thence northerly along the east boundaries of sections 27 and 34, township 23, range 29, west of the fourth meridian, and of sections 3 and 10, township 24, range 29, west of the fourth meridian, to the point of commencement.",

(b) by striking out the legal description of the Electoral Division of Edmonton and by substituting the following:

> "Electoral Division of Edmonton Centre, the boundary whereof is as follows: Commencing at the intersection of the centre line of 78th Street in the City of Edmonton with the centre line of the Canadian National Railway between 116th and 118th Avenues in the said city; thence southerly along the centre line of 78th Street to its intersection with the centre line of 112th Avenue South in the said city; thence easterly along the centre line of 112th Avenue South to the centre line of 76th Street in the said city; thence southerly along the centre line of 76th Street and its production southerly to the centre line of Rat Creek; thence in a generally south-easterly direction downstream along Rat Creek to the centre line of the North Saskatchewan River; thence in a generally south-westerly direction upstream along the centre line of the North Saskatchewan River to the production southerly of the east limit of 121st Street in the said city; thence northerly along the said production and along the said east limit of 121st Street to its intersection with the centre line of the Canadian National Railway aforesaid; thence easterly and north-easterly along the centre line of the Canadian National Railway to the point of commencement.

"Electoral Division of Edmonton North-East, the boundary whereof is as follows: Commencing at the intersection of the north boundary of section 19, township 53, range 23, west of

the fourth meridian with the left bank of the North Saskatchewan River; thence westerly along the north boundary of the said section 19 and along the north boundaries of sections 24, 23, 22 and 21, township 53, range 24, west of the fourth meridian; thence southerly along the east boundaries of sections 20 and 17, township 53, range 24, west of the fourth meridian to the centre line of the Canadian National Railway between 125th and 127th Avenues in the City of Edmonton; thence easterly along the said centre line of the Candian National Railway to the centre line of 82nd Street in the said city; thence southerly along the centre line of 82nd Street to the centre line of the Canadian National Railway between 112th and 114th Avenues in the said city; thence north-easterly along the said centre line of the Canadian National Railway to the centre line of 78th Street in the said city; thence southerly along the centre line of 78th Street to its intersection with the centre line of 112th Avenue South in the said city; thence easterly along the centre line of 112th Avenue South to the centre line of 76th Street in the said city; thence southerly along the centre line of 76th Street and along its production southerly to the centre of Rat Creek; thence in a generally south-easterly direction downstream along Rat Creek to the centre line of the North Saskatchewan River; thence in a generally north-easterly direction along the centre line of the North Saskatchewan River to the production southerly of the east boundary of River Lot 34 in the Edmonton Settlement; thence northerly along the said production to the left bank of the North Saskatchewan River; thence in a generally north-easterly direction along the said left bank to the point of commencement.

"Electoral Division of Edmonton Norwood, the boundary whereof is as follows: Commencing at the intersection of 82nd Street in the City of Edmonton with the centre line of the Canadian National Railway between 126th and 127th Avenues in the said city; thence southerly along the said centre line of 82nd Street to its intersection with the centre line of the Canadian National Railway between 112th and 114th Avenues in the said city; thence southwesterly along the said centre line of the Canadian National Railway to the centre line of 101st Street in the said city; thence northerly along the centre line of 101st Street to the centre line of 118th Avenue in the said city; thence easterly along the centre line of 118th

Avenue to the centre line of 97th Street in the said city; thence northerly along the centre line of 97th Street to the centre line of the Canadian National Railway between 125th and 127th Avenues in the said city; thence easterly along the centre line of the Canadian National Railway to the point of commencement.

"Electoral Division of Edmonton North, the boundary whereof is as follows: Commencing at the north-east corner of section 20, township 53, range 24, west of the fourth meridian; thence southerly along the east boundaries of sections 20 and 17 in the said township to the centre line of the Canadian National Railway between 125th and 127th Avenues in the City of Edmonton; thence easterly along the said centre line of the Canadian National Railway to the centre line of 97th Street in the said city; thence southerly along the centre line of 97th Street to the centre line of 118th Avenue in the said city; thence westerly along the centre line of 118th Avenue to the centre line of 101st Street in the said city; thence southerly along the centre line of 101st Street to the centre line of the Canadian National Railway between 104th and 105th Avenues in the said city; thence westerly and northerly along the said centre line of the Canadian National Railway to the centre line of 107th Avenue in the said city; thence westerly along the centre line of 107th Avenue to the centre line of 127th Street in the said city; thence northerly along the centre line of 127th Street to the centre line of the Canadian National Railway between 125th and 127th Avenues in the said city; thence easterly along the said centre line of the Canadian National Railway to the production southerly of the centre line of 115th Street in the said city; thence northerly along the said production and along the centre line of 115th Street to the north boundary of section 19, township 53, range 24, west of the fourth meridian; thence easterly along the north boundaries of sections 19 and 20 in the said township to the point of commencement.

"Electoral Division of Edmonton North-West, the boundary whereof is as follows: Commencing at the intersection of the centre line of 115th Street in the City of Edmonton with the north boundary of section 19, township 53, range 24, west of the fourth meridian; thence westerly along the north boundary of the said section 19 and along the north boundaries of sections 24, 23 and 22, township 53, range 25, west of the fourth meridian to the north-east corner

of section 21, township 53, range 25, west of the fourth meridian; thence southerly along the east boundaries of sections 21, 16, 9 and 4, township 53, range 25, west of the fourth meridian to the centre line of provincial highway No. 16 as shown on a plan of record in the Land Titles Office for the North Alberta Land Registration District as Road Plan No. 1400 J.Y.; thence north-easterly along the centre line of provincial highway No. 16 to the south boundary of the north-west quarter of section 3, township 53, range 25, west of the fourth meridian; thence easterly along the said south boundary of the north-west quarter of section 3 to the south-east corner thereof; thence northerly along the east boundary of the said north-west quar-ter of section 3 to the centre line of 107th Avenue in the Town of Jasper Place; thence easterly along the said centre line to the centre line of 156th Street in the said town; thence southerly along the centre line of 156th Street to the centre line of 107th Avenue in the said town; thence easterly along the centre lines of 107th Avenue in the said town and 107th Avenue in the City of Edmonton to the centre line of 127th Street in the said city; thence northerly along the centre line of 127th Street to the centre line of the Canadian National Railway between 125th and 127th Avenues in the said city; thence easterly along the said centre line of the Canadian National Railway to the production southerly of the centre line of 115th Street in the said city; thence northerly along the said production and along the centre line of 115th Street to the point of commencement.

"Electoral Division of Strathcona East, the boundary whereof is as follows: Commencing at the intersection of the centre line of the North Saskatchewan River with the production northerly of the east boundary of River Lot 29 in the Edmonton Settlement; thence in a generally south-westerly direction along the said centre line of the North Saskatchewan River to the production north-westerly of the centre line of Strathcona Road in the City of Edmonton; thence south-easterly and north-easterly along the centre lines of Strathcona Road and 98th Avenue respectively to the centre line of Connors Road in the said city; thence southerly along the centre line of Connors Road to its intersection with Mill Creek; thence in a generally southerly direction upstream along Mill Creek to its intersection with the westerly limit of 91st Street in the said city; thence southerly along the westerly limit of 91st Street to the north-east corner of section 16, township 52, range 24, west of the fourth meridian; thence easterly along the north boundary of section 15 in the said township to the north-east corner of the said section 15; thence northerly along the east boundaries of sections 22, 27 and 34 in the said township and along the east boundary of River Lot 29 aforesaid and its production northerly to the point of commencement.

"Electoral Division of Strathcona Centre, the boundary whereof is as follows: Commencing at the point of intersection of the centre line of the North Saskatchewan River with the centre line of the Calgary and Edmonton branch of the Canadian Pacific Railway as shown on a plan of record in the Land Titles Office for the North Alberta Land Registration District as Railway Plan No. 1; thence in a generally north-easterly direction downstream along the said centre line of the North Saskatchewan River to its intersection with the production north-westerly of the centre line of Strathcona Road in the City of Edmonton; thence south-easterly and north-easterly along the centre lines of Strathcona Road and 98th Avenue respectively to the centre line of Connors Road in the said city; thence southerly along the centre line of Connors Road to its intersection with Mill Creek; thence in a generally southerly direction upstream along Mill Creek to its intersection with the westerly limit of 91st Street in the said city; thence southerly along the westerly limit of 91st Street to the north-east corner of the north-east quarter of section 16, township 52, range 24, west of the fourth meridian; thence westerly along the north boundary of the said northeast quarter of section 16 to the north-west corner thereof; thence southerly along the west boundary of the said quarter section to the south-west corner thereof; thence easterly along the south boundary of the said quarter section to the north-east corner of Block 11 in Speedway subdivision as shown on a plan of record in the said Land Titles Office as Plan No. 1930-R; thence southerly along the east boundary of the said Block and its production southerly to the south boundary of the said Speedway subdivision; thence westerly along the south boundary of the said Speedway subdivision to the east boundary of the rightof-way of the Calgary and Edmonton branch

of the Canadian Pacific Railway as shown on the said Railway Plan No. 1; thence southerly along the east boundary of the said right-ofway to the north boundary of section 9, township 52, range 24, west of the fourth meridian; thence westerly along the north boundary of sections 9 and 8 in the said township to the north-west corner of the north-east quarter of the said section 8; thence northerly along the west boundary of the south-east quarter of section 17 in the said township to the northwest corner of the said quarter section; thence easterly along the north boundary of the southeast quarter of the said section 17 to the centre line of 106th Street in the said city; thence northerly along the said centre line of 106th Street to the centre line of University Avenue in the said city; thence westerly along the centre line of University Avenue to the centre line of 109th Street in the said city; thence northerly along the centre line of 109th Street to its intersection with the centre line of the Calgary and Edmonton branch of the Canadian Pacific Railway aforesaid; thence northerly along the centre line of the said Calgary and Edmonton branch of the Canadian Pacific Railway to the point of commencement.

"Electoral Division of Strathcona West, the boundary whereof is as follows: Commencing at the point of intersection of the centre line of the North Saskatchewan River with the centre line of the Calgary and Edmonton branch of the Canadian Pacific Railway as shown on a plan of record in the Land Titles Office for the North Alberta Land Registration District as Railway Plan No. 1; thence in a generally south-westerly direction upstream along the said centre line of the North Saskatchewan River to the north boundary of section 15, township 52, range 25, west of the fourth meridian; thence easterly along the north boundaries of sections 15, 14 and 13 in the said township and of section 18, township 52, range 24, west of the fourth meridian; thence southerly along the east boundary of the north-east quarter of the said section 18 to the south-east corner of the said quarter section; thence easterly along the north boundary of the south-west quarter of section 17, township 52, range 24, west of the fourth meridian and its production easterly to the centre line of 106th Street in the City of Edmonton; thence northerly along the centre line of 106th Street to the centre line of University Avenue in the said city; thence westerly along the centre line of University Avenue to the centre line of 109th Street in the said city; thence northerly along the centre line of 109th Street to its intersection with the centre line of the Calgary and Edmonton branch of the Canadian Pacific Railway aforesaid; thence northerly along the centre line of the said Calgary and Edmonton branch of the Canadian Pacific Railway to the point of commencement.

"Electoral Division of Jasper West, the boundary whereof is as follows: Commencing at the intersection of the centre line of 107th Avenue in the City of Edmonton with the centre line of the Canadian National Railway at 121st Street in the said city; thence southerly and south-easterly along the centre line of the said Canadian National Railway to the east limit of 121st Street in the said city; thence southerly along the east limit of 121st Street and its production southerly to the centre line of the North Saskatchewan River; thence in a generally south-westerly direction upstream along the centre line of the North Saskatchewan River to the north boundary of section 15, township 52, range 25, west of the fourth meridian; thence westerly along the said north boundary of section 15 to the left bank of the North Saskatchewan River; thence in a generally south-westerly direction along the said left bank to the east boundary of section 16 in the said township; thence northerly along the east boundaries of sections 16, 21, 28 and 33 in the said township and of section 4, township 53, range 25, west of the fourth meridian to the centre line of provincial highway No. 16 as shown on a plan of record in the Land Titles Office for the North Alberta Land Registration District as Road Plan No. 1400 J.Y.; thence north-easterly along the centre line of provincial highway No. 16 to the south boundary of the north-west quarter of section 3, township 53, range 25, west of the fourth meridian; thence easterly along the said south boundary and northerly along the east boundary of the said north-west quarter of section 3 to the centre line of 107th Avenue in the Town of Jasper Place; thence easterly along the centre line of 107th Avenue to the centre line of 156th Street in the said town; thence southerly along the centre line of 156th Street to the centre line of 107th Avenue in the said town; thence easterly along the centre lines of 107th Avenue in the said town and of 107th Avenue in the City of Edmonton to the point of commencement.",

(c) by striking out the legal description of the Electoral

Division of Peace River and by substituting the following:

"Electoral Division of Peace River, the boundary whereof is as follows: Commencing at the intersection of the fifth meridian with the north boundary of the province; thence southerly along the said fifth meridian to the north-east corner of township 82, range 1, west of the fifth meridian; thence westerly along the north boundary of township 82, ranges 1 to 22 inclusive, west of the fifth meridian to the left bank of the Smoky River; thence in a generally south-westerly direction upstream along the the said left bank to the north boundary of township 80, range 23, west of the fifth meridian; thence westerly along the north boundary of township 80, ranges 23, 24 and 25, west of the fifth meridian to the left bank of the Peace River; thence in a generally southwesterly direction upstream along the left bank of the Peace River to its intersection with the sixth principal meridian; thence northerly along the sixth principal meridian to the northeast corner of township 85, range 1, west of the sixth meridian; thence westerly along the north boundary of the said township 85 to the north-east corner of township 85, range 2, west of the sixth meridian; thence northerly along the meridian between ranges 1 and 2, west of the sixth meridian to the north boundary of township 96; thence easterly along the north boundary of township 96, range 1, west of the sixth meridian to the sixth principal meridian; thence northerly along the sixth principal meridian to the north boundary of the province; thence easterly along the north boundary of the province to the point of commencement.

"Electoral Division of Dunvegan. comprising all that part of the province lying north of the Peace River and west of the sixth meridian excepting thereout townships 86 to 96 inclusive, range 1, west of the sixth meridian.".

5. This Act comes into force on a day to be fixed by proclamation of the Lieutenant Governor in Council.
