# BILL 2

A Bill to amend an Act to incorporate the Highwood Western Railway Company, being chapter 74 of the Statutes of Alberta, 1946

## **Explanatory Note**

#### 2. Section 14 of the Act presently reads:

"14. The construction of the railway hereby authorized shall be commenced within two years and shall be completed within five years from the 31st day of March, 1956, and section 70 of The Railway Act does not apply to the Company."

Section 70 of The Railway Act, being chapter 276 of The Revised Statutes of Alberta, 1955, reads:

- "70. (1) If the railway authorized by the special Act to be constructed is of a length not greater than thirty miles the company shall construct and put the railway in operation within two years from the date of its incorporation.
- "(2) If the railway is of greater length than thirty miles the company shall
- "(a) construct and put in operation thirty miles within two years from the date of its incorporation,
  "(b) construct and put in operation at least thirty miles during each year immediately following the expiration of the said two years, and
- "(c) complete the whole railway within five years from the date of incorporation.

  "(3) If the company fails to comply with this section then the power granted by the special Act or by this Act ceases and is null and void as respects so much of the railway as then remains uncompleted."

WHEREAS Highwood Western Railway Company has Preamble presented a Petition praying for the amendment of the Act incorporating the said Company, being chapter 74 of the Statutes of Alberta, 1946, as hereinafter set forth, and it is expedient to grant the prayer of the said Petition:

Therefore, Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

- 1. An Act to incorporate the Highwood Western Railway Company, being chapter 74 of the Statutes of Alberta, 1946, is hereby amended.
- 2. Section 14 is struck out and the following is sub-Section 14 stituted:
- "14. The construction of the railway hereby authorized shall be commenced within two years and shall be completed construction within five years from the 31st day of March, 1958, and section 70 of *The Railway Act* does not apply to the Company."
- 3. This Act comes into force on the day upon which it is coming assented to.
