## **BILL 43**

A Bill to amend The Pipe Line Taxation Act

## **Explanatory Note**

**General.** In 1957 the Legislature enacted The Municipalities Assessment and Equalization Act and The Assessment Appeal Board Act. As a result of the changes made by these Acts and for greater administrative efficiency it is proposed to abolish the position of Director of Assessments and to divide his duties between a Supervisor of Assessments and an Assessment Commissioner.

**2.** (a) The duty of the Director to assess pipe lines is transferred to the Supervisor and a reference to the repealed The Alberta Municipal Assessment Commission Act is removed.

(b) (i) Reference changed from Director to Supervisor.

(b) (ii) Reference to the defunct Alberta Assessment Commission replaced.

(b) (iii) To comply with The Assessment Appeal Board Act notices of appeal will be sent to the Board instead of to the Director of Assessments as at present.

(c) Reference to a repealed Act is removed.

(d) Reference changed from the Director to the Supervisor.

(e) Reference to the defunct Alberta Assessment Commission changed to refer to the Alberta Assessment Appeal Board which replaced it.

# BILL

No. 43 of 1958

An Act to amend The Pipe Line Taxation Act

**H**ER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

**1.** *The Pipe Line Taxation Act*, being chapter 235 of The Revised Statutes of Alberta, 1955, is hereby amended.

**2.** Section 3 is amended

(a) as to subsection (2) by striking out all the words preceding clause (a) and by substituting the following:

“(2) The Supervisor of Assessments appointed pursuant to *The Municipalities Assessment and Equalization Act* shall before the first day of July in each year,”

(b) as to subsection (3)

(i) by striking out the word “director” where it occurs in clause (b) and by substituting the words “Supervisor of Assessments”,

(ii) by striking out the words “assessment commission” and by substituting the words “Appeal Board”,

(iii) by striking out the words “to the director” and by substituting the words “to the Board”,

(c) as to subsection (5) by striking out the words “*The Alberta Municipal Assessment Commission Act*” and by substituting the words “*The Assessment Appeal Board Act*”,

(d) as to subsection (6) by striking out the word “director” and by substituting the words “Supervisor of Assessments”,

(e) as to subsection (7) by striking out the word “Commission” and by substituting the words “Appeal Board”.

**3.** This Act comes into force on the day upon which it is assented to.
