SCHEDULE I

PROVISIONS OF ACTS

Explanatory Note

BILL NO

General. Certain orders in council set out in this Bill and increasing the pensions payable under The Disabled Persons' Pensions Act and The Widows' Pensions Act to conform with an increase in pensions made by the Government of Canada late in 1957, are to be ratified hereby. The commencement date is made retroactive to November 1st, 1957.

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. This Act may be cited as "*The Orders in Council 246/58 and 247/58 Validation Act*".

2. That certain Order in Council dated the seventeenth day of February, 1958 and intituled Order in Council 246/58 and set out as Schedule I to this Act, and that certain Order in Council dated the seventeenth day of February 1958, and intituled Order in Council 247/58 and set out as Schedule II to this Act, are hereby validated, ratified and confirmed and shall have the same force and effect as if they had been enacted by this Act.

3. This Act comes into force on the day upon which it is assented to and upon so coming into force shall be deemed to have been in force at all times on and after the first day of November, 1957.

Therefore, upon the recommendation of the Honourable the Minister of Public Welfare, the Executive Council advises that, the pension under *The Disabled Persons' Pensions Act* be and is hereby increased from Forty-six Dollars a month to Fifty-five Dollars a month to be effective on and after the First day of November, 1957, and that this Order in Council is made subject to ratification at the next ensuing Session of the Legislature.
