A Bill to Amend The Lloydminster Municipal
Amalgamation Act, 1930

HON. MR. HOOKE

Explanatory Note

General. This Bill is complementary to one to be enacted by Saskatchewan dealing with the same subject matter.

By complementary Orders in Council in Alberta and Saskatchewan, numbered 2012/57 and 2329/57, respectively, the composite area under The Lloydminster Municipal Amalgamation Acts, 1930 (Alta. 1930, c. 54, and Sask. 1930 c. 94) was made a city. A charter for the City of Lloydminster was granted by complementary Orders in Council in Alberta and Saskatchewan, numbered respectively, 288/58 and 51/58. This Act and the complementary Saskatchewan Act would ratify the aforesaid orders in council, effective the first day of January, 1958.

2. Section 15, which is being repealed, is the commencement section of the 1930 Act.

Subsections (1), (2) and (3) self-explanatory.

HER MAJESTY, by and with the advice and consent of
the Legislative Assembly of the Province of Alberta,
enacts as follows:

1. This Act may be cited as "*The Lloydminster Amalgamation Amendment Act, 1958*".

2. *The Lloydminster Municipal Amalgamation Act, 1930*, being chapter 54 of the Statutes of Alberta, 1930, is amended by striking out section 15 and by substituting the following:

"**15.** (1) The order of the Lieutenant Governor in Council, numbered 2012/57 and dated the thirty-first day of December, 1957, declaring the area constituting the composite area to be a city is ratified and confirmed.

"(2) The order of the Lieutenant Governor in Council, numbered 288/58 and dated the twenty-fourth day of February, 1958, approving a charter for the composite area and declaring the charter to be applicable to the composite area, is ratified and confirmed, and the charter so approved shall be deemed to have been the charter of the composite area on, from and after the first day of January, 1958, and the charter, including any amendments thereafter made thereto, or any revision or consolidation thereof, shall serve as the charter for the government of the composite area.

"(3) The council of the composite area in office on the first day of January, 1958, shall be the council of the composite area thereafter and until succeeded by a new council elected under the provisions of the said charter, and the council and succeeding councils possess all the rights, powers and authority and shall assume all the liabilities conferred or imposed upon the council of the composite area by this Act, by the charter and by any complementary orders in council hereafter passed.

(4) Makes a necessary change of references in section 14 of the Act.

“(4) With respect to debentures issued by the council of the composite area after the thirty-first day of December, 1957, section 14 shall be read and construed as if the words and figures “section 642 of *The City Act*” were substituted for the words and figures “section 351 of *The Village Act, 1927*” in the seventh and eighth line, and as if the word “city” were substituted for the word “village” in the ninth line.”.

3. This Act comes into force on the day upon which it is assented to and upon so coming into force shall be deemed to have been in force at all times on and after the first day of January 1958.
