Explanatory Note

The purpose of this Bill is to provide a tax exemption (other than local improvement taxes) from municipal taxes in respect of certain property of the corporation named herein, in the town of Falher, Alberta.

WHEREAS a petition has been presented praying for an amendment to An Act to Incorporate La Corporation Des Soeurs De Sainte-Croix et Des Sept Douleurs, being chapter 116 of the Statutes of Alberta, 1957, for the purpose of exempting from taxation certain property located in the town of Falher, Alberta; and

Preamble

Whereas it is expedient to grant the said petition.

Therefore, Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. Chapter 116 of the Statutes of Alberta, 1957, being An Act to Incorporate La Corporation Des Soeurs De Sainte-Croix et Des Sept Douleurs, is amended by adding after section 15 the following:

section 15a

15a. The following property located in the town of Falher, Alberta, and described as follows, namely:

- (a) commencing at a point on the North boundary of Block 1 in the Townsite of Falher, as shown on subdivision Plan 5556 C.C., said point being 470 ft. easterly distant from the North West corner of Parcel (B) as shown on File Plan 6165 E.T.; THENCE Easterly along the said North Boundary 265 ft. THENCE Southerly and parallel to the West boundary of the said Parcel (B) 270 ft. THENCE Westerly and parallel to the said North Boundary 265 ft. THENCE Northerly and in a straight line to the point of commencement.
- (b) The Easterly one hundred and seventy-five (175) feet in uniform width throughout of Parcel (B) as shown on filed Plan 6165 E.T. being a portion of Block One (1) in the townsite of Falher in the Province of Alberta, Dominion of Canada as shown on subdivision Plan 5556 C.C. Containing one and sixty-seven hundredths (1.67) acres more or less. (N.W. 4-78-21-W. 5).

Reserving thereout all Mines and Minerals.

shall be exempt from taxation so long as the same is used for educational purposes except for local improvement taxes and taxes pertaining to minerals.

2. This Act shall come into force on the day upon which it is assented to.
