- 1. The Mines and Minerals Act, being chapter 204 of the Revised Statutes, is hereby amended.
- 2. Section 295 is amended by striking out the words "Form E in the Schedule" where they occur in clause (c) and by substituting the words "Form E, F or G in the Schedule".
