Explanatory Note

2. Where a quarantine is made under this section, section 7, relating to bringing bees into the Province, has to be looked to to find the effect of a quarantine order in subsection (2), clause (b). Section 6(1) relates to quarantine and the substance of section 7(2) (b) is transferred. See note to clause 3.

3. Subsection (2) of section 7 deals with quarantine of bees, while subsection (1) deals with importing bees into the Province. The section is made two sections to separate the two topics.

4. New. Self-explanatory.

An Act to amend The Bee Diseases Act

(Assented to , 1960)

H^{ER} MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. The Bee Diseases Act, being chapter 20 of the Revised Statutes, is hereby amended.

2. Section 6 is amended by adding the following subsection immediately after subsection (2):

(3) Where a quarantine order is made pursuant to subsection (1), no person shall remove from the premises any of the bees, the honey or hives thereof or any equipment used in connection with the bees, until an inspector has given his written permission to do so.

3. Section 7 is amended

(a) by striking out the figure (1),

(b) by renumbering subsection (2) as section 7a.

4. The following sections are added immediately after section 11:

11*a*. Honey shall be extracted in a place to which bees cannot gain access, either during or after the extracting process.

11*b.* No person shall transport supers of honeycombs within the Province unless

- (a) the supers are so tightly covered as to prevent access thereto by bees, or
- (b) the supers are transported in such a manner as to prevent access thereto by bees.

11*c***.** (1) An inspector may order any owner or person in charge of any used hive or used bee equipment lying neglected or abandoned to place the hive or equipment in an enclosure so constructed as to prevent access thereto by bees.

(2) Where there is default in complying with an order under subsection (1), or in the opinion of the inspector the enclosure is unsatisfactory for the purpose of preventing access by bees, the inspector may direct the destruction of or himself destroy, in either case at the expense of the party in default, the used hives and used bee equipment.

5. This Act comes into force on the day upon which it is assented to.
