## **BILL 119**

A Bill to amend The Municipal Hospitals Act

## Explanatory Note

**2. Section 103(1) presently reads:**

"103. (1) Debentures shall not carry interest at a greater rate than six per cent per annum."

**3. Section 110(1) (a) presently reads:**

"110. (1) On or before the fifteenth day of February in each year the appropriate officer of each included area within which a municipal hospital district is situated in whole or in part shall provide a certificate to the secretary-treasurer of the hospital board showing

(a) the total assessed value of all land together with sixty per cent of the fair actual value of all buildings and improvements liable, under and pursuant to The Assessment Act, or any Act substituted therefor, to assessment at the thirty-first day of December in the preceding year in that part of the municipality that is within the municipal hospital district or where land, buildings and improvements in a municipality are assessed on a different index of value from that used in other municipalities in the same municipal hospital district, the amount determined and ordered by the Alberta Assessment Equalization Board pursuant to The Municipalities Assessment and Equalization Act for the purpose of equitably apportioning the requisitions upon municipalities within the municipal hospital district, and"

**4. Section 112, subsection (1) presently reads:**

"112. (1) Before the fifteenth day of March in each year, the board shall send to each contributing council a requisition for that part of the estimate attributed to such council."

**5. Form E, being the prescribed form for a debenture by-law, is amended to conform with the amendment to section 103(1) (see clause 2) by removing the interest rate figure of 6% and leaving a blank space to be filled by the rate established under section 103(1).**

An Act to amend The Municipal Hospitals Act

(Assented to \_\_\_\_\_, 1960)

**H**ER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

**1.** *The Municipal Hospitals Act*, being chapter 216 of the Revised Statutes, is hereby amended.

**2.** Section 103, subsection (1) is amended by striking out the words "than six per cent per annum" and by substituting the words "per annum than the rate fixed by the Lieutenant Governor in Council".

**3.** Section 110, subsection (1) is amended

(a) by striking out the words "fifteenth day of February" and by substituting the words "first day of April",

(b) by striking out clause (a) and by substituting the following:

(a) the amount of the equalized assessment in that part of the municipality that is within the municipal hospital district based on the equalized assessment of the municipality as may be determined and ordered by the Alberta Assessment Equalization Board for that year pursuant to *The Municipalities Assessment and Equalization Act*, and

**4.** Section 112, subsection (1) is amended by striking out the words "fifteenth day of March" and by substituting the words "fifteenth day of May".

**5.** Form E of the Schedule is amended by striking out the word "six" wherever it occurs.

**6.** (1) This Act, except sections 3 and 4, comes into force on the day upon which it is assented to.

(2) Sections 3 and 4 come into force on the first day of January, 1961.
