## **BILL 44**

A Bill to amend The Public Service Pension Act

---

## **Explanatory Note**

**2. Section 2, clause (b) presently reads:**

“(b) “Director of Personnel” means the administrative officer who is so designated in The Public Service Act and is appointed under that Act;”.

**As a result of recent amendments to The Public Service Act there is no longer an officer so designated under that Act.**

**3. Section 4 is revised to remove a reference to the Director of Personnel. See note to clause 2 above.**

**4. Section 7 provides for the crediting of interest on contributions deducted from an employee's salary. Section 7, subsection (2) presently reads:**

“(2) In respect of every account such interest shall continue to be so credited until the date of termination of the employee's service.”.

**5. Section 31, subsection (1), clause (a) presently reads:**

“31. (1) Subject to The Treasury Department Act and subject to the approval of the Lieutenant Governor in Council, the Board may

(a) prescribe forms for its use and for the use of the Director of Personnel in connection with the administration of this Act,”.

**See note to clause 2 of this Bill.**

**6. Section 33, subsections (2) and (4) presently read:**

“(2) This Act applies mutatis mutandis to University employees other than

(a) members of the academic staff, and

(b) such other University employees as the Governors of the University of Alberta may exclude by regulations approved by the Lieutenant Governor in Council from the operation of this Act.

(4) On or before the last day of each month the Governors of the University of Alberta shall contribute to the General Revenue Fund an amount equivalent to the total amount contributed during that month by the University employees, other than those excluded from the application of this Act.”.

**7. Validation of existing arrangements.**

An Act to amend The Public Service Pension Act

(Assented to \_\_\_\_\_, 1961)

**H**ER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

**1.** *The Public Service Pension Act*, being chapter 264 of the Revised Statutes, is hereby amended.

**2.** Section 2 is amended by striking out clause (b).

**3.** Section 4 is struck out and the following is substituted:

**4.** Subject to *The Public Service Act*, the Lieutenant Governor in Council may appoint a secretary of the Board and such clerks or other assistants necessary for the administration of this Act.

**4.** Section 7, subsection (2) is amended by adding immediately after the word "until" the words "the end of the calendar month immediately preceding".

**5.** Section 31, subsection (1), clause (a) is amended by striking out the words "Director of Personnel" and by substituting the words "secretary of the Board".

**6.** Section 33 is amended

(a) as to subsection (4) by striking out the words "On or before the last day of each" and by substituting the word "Each",

(b) by adding immediately after subsection (4) the following:

(5) Where an employee of the Government who is making contributions pursuant to this Act is transferred to the University of Alberta as a member of the academic staff, he may elect to continue making contributions under this Act and upon such election this section applies to him notwithstanding clause (a) of subsection (2).

**7.** Any agreement or arrangement entered into before the day upon which this Act comes into force whereby

- (a) an employee transferred to the academic staff of the University of Alberta was permitted to continue making contributions under *The Public Service Pension Act* or under *The Superannuation Act*, being chapter 36 of the Revised Statutes of Alberta, 1942, or
- (b) a member of the academic staff of the University of Alberta became an employee of the Government and was given credit for any contributions previously made to a pension fund while so employed by the University,

is hereby validated and this Act applies *mutatis mutandis* to such persons.

**8.** This Act comes into force on the day upon which it is assented to.
