A Bill to Validate Certain By-Laws of the City of Calgary

HON. MR. HOOKE

Explanatory Note

It has recently come to the attention of the City of Calgary that its procedure in levying a uniform mill rate on the total assessable property in the city regardless of the actual demand by either the public or separate school districts is not in accordance with the requirements of section 523 of The City Act and section 9 of The School Act. This irregular procedure dates back to the time when The City Act first came into force. This Bill is intended to validate these by-laws.

An Act to Validate Certain By-Laws of The City of Calgary

(Assented to _____, 1961)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. This Act may be cited as "*The Calgary By-Law Validation Act, 1961*".

2. The following By-Laws of The City of Calgary, namely:

- (a) By-law 4206, a By-law intituled a By-law to fix and levy the rate for taxes to be collected for the year 1951,
- (b) By-law 4296, a By-law intituled a By-law to fix and levy the rate for taxes to be collected for the year 1952,
- (c) By-law 4421, a By-law intituled a By-law to fix and levy the rate for taxes to be collected for the year 1953,
- (d) By-law 4565, a By-law intituled a By-law to fix and levy the rate for taxes to be collected for the year 1954,
- (e) By-law 4710, a By-law intituled a by-law to fix and levy the rate for taxes to be collected for the year 1955,
- (f) By-law 4842, a By-law intituled a By-law to fix and levy the rate for taxes to be collected for the year 1956,
- (g) By-law 4945, a By-law intituled a By-law to fix and levy the rate for taxes to be collected for the year 1957,
- (h) By-law 5068, a By-law intituled a By-law to fix and levy the rate for taxes to be collected for the year 1958,
- (i) By-law 5236, a By-law intituled a By-law to fix and levy the rate for taxes to be collected for the year 1959, and
- (j) By-law 5457, a By-law intituled a By-law to fix and levy the rate for taxes to be collected for the year 1960,

are hereby validated and confirmed and declared to be legal,

valid and binding upon the City of Calgary and the proprietary electors and the electors thereof and the by-laws shall not be questioned in any court on any ground whatever and all or any rates levied under the by-laws are hereby declared to be legal, valid and binding on the City of Calgary and the ratepayers or proprietary electors thereof and shall not be questioned in any court on any ground whatever.

3. This Act comes into force on the day upon which it is assented to.
