An Act to amend The Legislative Assembly Act and The Election Act

(Assented to , 1961)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. The Legislative Assembly Act, being chapter 174 of the Revised Statutes, is amended by striking out Schedule 1 and by substituting the following:
