Explanatory Note

General. The Acts set out in this Bill are no longer operative as the matters which they were intended to deal with are now being dealt with under The Hospitalization Benefits Act, 1959, and The Municipal Hospitals Act.

An Act to repeal Certain Acts of the Legislature (No. 2)

(Assented to _____, 1961)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. The following Acts are hereby repealed:

- (a) *The Red Deer Memorial Hospital Ordinance*, being chapter 21 of the Statutes of Alberta, 1902;
- (b) *An Ordinance to incorporate "The Memorial Hospital of Pincher Creek"*, being chapter 22 of the Statutes of Alberta, 1902;
- (c) *An Act to Incorporate the Lacombe General Hospital of Lacombe*, being chapter 47 of the Statutes of Alberta, 1907;
- (d) *The Scandinavian Hospital in Wetaskiwin Act*, being chapter 38 of the Statutes of Alberta, 1908;
- (e) *An Act to Incorporate the High River General Hospital of High River*, being chapter 13 of the Statutes of Alberta, 1910;
- (f) *Lady Minto Hospital Act*, being chapter 59 of the Statutes of Alberta, 1913;
- (g) *An Act to incorporate the South Hall Hospital, Edmonton*, being chapter 57 of the Statutes of Alberta, 1919;
- (h) *An Act to Incorporate Al Azhar Temple Crippled Children's Hospital*, being chapter 73 of the Statutes of Alberta, 1932;
- (i) *The Lacombe and District Community Hospital Act*, being chapter 10 of the Statutes of Alberta, 1937 (Second Session).
- (j) *The Olds and District General Hospital Act*, being chapter 74 of the Statutes of Alberta, 1938;
- (k) *The Didsbury and District General Hospital Act*, being chapter 75 of the Statutes of Alberta, 1938;
- (l) *The Berwyn and District Hospital Act*, being chapter 38 of the Statutes of Alberta, 1939;
- (m) *The Coal Branch Hospital District Act*, being chapter 17 of the Statutes of Alberta, 1945;

- (n) *The Hospitalization of City Residents Act*, being chapter 145 of the Revised Statutes;
- (o) *The Maternity Hospitalization Act*, being chapter 196 of the Revised Statutes.

2. This Act comes into force on the day upon which it is assented to.
