A Bill to amend The Cultural Development Act

**Explanatory Note** 

2. Section 3 presently reads: "3. The Lieutenant Governor in Council, on the recommendation of the Minister, may establish boards, each consisting of not more than seven members, whose function shall be the encouragement, co-ordination, expansion and development of different aspects of the cultural life of the Province, and in particular, library facilities in both urban and rural districts, music, art, drama, handicrafts and physical recreation.".

3. A new subsection is added to section 4 which provides for limiting board appointments to two successive two-year terms.

#### 4. Section 6 presently reads:

"6. Without limiting the generality of the functions of a board as set out in section 3, a board,

- (a) may carry out surveys, encourage community activities, call public meetings, promote publicity campaigns, and may carry on its activities in co-operation with or through an established or-ganization or agency, and generally may do any act or thing having for its purpose the promotion of the field or fields of the cultural activity with which it is concerned,
- (b) may raise funds by public subscription to be used in the pro-motion and advancement of the field of the cultural activity with which it is concerned, and shall cause to be kept a proper record of the funds collected and of all disbursements, which record shall be audited and shall appear in the annual report of the board submitted to the Minister.".

5. Section 10 provides for the appointment and duties of the Director of Recreation and Cultural Development. Subsection (2) presently reads:

"(2) Subject to The Public Service Act, the Lieutenant Governor in Council may also appoint such officers, clerks and servants as may be required.".

#### An Act to amend The Cultural Development Act

#### (Assented to , 1962)

**H**<sup>ER</sup> MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

**1.** The Cultural Development Act, being chapter 73 of the Revised Statutes, is hereby amended.

**2.** Section 3 is struck out and the following section is substituted :

**3.** The Lieutenant Governor in Council upon the recommendation of the Minister may establish boards each consisting of not more than seven members whose function shall be to advise the Minister on the encouragement, coordination, expansion and development of different aspects of the cultural life of the Province.

**3.** Section 4 is amended by adding immediately after subsection (3) the following:

(4) Board members may be appointed for two consecutive terms following which at least one year must elapse before re-appointment.

**4.** Section 6 is struck out and the following section is substituted:

**6.** Without limiting the generality of the functions of a board as set out in section 3, a board, with the approval of the Minister, may carry out surveys, encourage community activities, call public meetings, promote publicity campaigns, and may carry on its activities in co-operation with or through an established organization or agency, and generally may do any act or thing having for its purpose the promotion of the field or fields of the cultural activity with which it is concerned.

5. Section 10 is amended by adding immediately after subsection (2) the following:

(3) The Minister may appoint any person employed under subsection (2) to act as the secretary to a board.

**6.** Authority is given to make regulations respecting the giving of courses and the employment of part-time staff.

7. Commencement of Act.

6. The following new section is added immediately after section 14:

15. The Lieutenant Governor in Council may make regulations respecting

- (a) the hiring of part-time staff and the payment of wages and other expenses to them or the provision of honorariums,
- (b) the rental of buildings and other facilities in which to conduct courses,
- (c) the collection of registration fees from candidates attending courses,
- (d) the payment of board and lodging for candidates attending courses,
- (e) the purchase or rental of equipment and material required for courses, and
- (f) any other matter necessary or advisable to carry out the intent and purpose of the Act.

7. This Act comes into force on the day upon which it is assented to.
