Explanatory Note

- 2. Section 2, clauses (c) and (h) presently read:
 - "(e) "council" means
 - (i) the council of a municipality, and
 - (ii) in the case of an improvement district or a special area the Minister of Municipal Affairs or such person as he may designate;
 - designate;

 "(h) "municipality" means a village, town, city with a population not exceeding fifty thousand, municipal district, county, improvement district or special area;".
- 3. Self-explanatory.
- 4. Section 13, subsection (2) presently reads:

"(2) The board may pay salaries in excess of those approved under subsection (1), but the excess salaries shall not be considered in calculating the statutory deductions to be made under The Public Service Pension Act.".

5. Section 14 presently reads:

- "14. (1) The Public Service Pension Act applies to the staff of a health unit employed under this Act.
- (2) A person shall be deemed to be an employee within the meaning of The Public Service Pension Act where
 - (a) the person is employed part-time by each of two or more health units, and
- (b) the total of the part-time employment by health units is equivalent to full-time continuous employment by one health unit, and statutory deductions shall be made in respect of the part of his salary that he receives from each health unit.
- (3) The statutory deductions directed by section 5 of The Public Service Pension Act shall at the times provided in that section be made and paid into the General Revenue Fund by the board instead of by the Provincial Treasurer.
- (4) On or before the last day of each month a contribution, of an amount equivalent to the total amount contributed by the staff of the health unit in that monh, shall be made by the board to the General Revenue Fund.".

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

- 1. The Health Unit Act, being chapter 139 of the Revised Statutes, is hereby amended.
 - 2. Section 2 is amended
 - (a) as to clause (c)
 - (i) by striking out the word "and" at the end of subclause (i) and by adding the word "and" at the end of subclause (ii),
 - (ii) by adding immediately after subclause (ii) the following new subclause:
 - (iii) in the case of a metis colony the Minister of Public Welfare or such person as he may designate;
 - (b) as to clause (h) by striking out the words "or special area" and by substituting the words ", special area or metis colony".
- 3. Section 9 is amended by adding immediately after subsection (1) the following:
- (1a) A board may not enter into a lease of office accommodation for a term of more than three years unless the lease provides that it may be terminated at any time by either party upon not more than one year's notice to the other.
- 4. Section 13, subsection (2) is amended by adding immediately after the words "The Public Service Pension Act" the words "or The Temporary Provincial Employees Retirement Act".
 - 5. Section 14 is amended
 - (a) as to subsection (1) by striking out the word "applies" and by substituting the words "and The Temporary Provincial Employees Retirement Act apply",
 - (b) as to subsection (2) by adding immediately after

- the words "The Public Service Pension Act" the words "or The Temporary Provincial Employees Retirement Act",
- (c) by striking out subsections (3) and (4) and by substituting the following:
 - (3) The deduction to be made under
 - (a) section 6 of The Public Service Pension Act, or
 - (b) section 6 of The Temporary Provincial Employees Retirement Act,
 - as the case may be, shall at the time provided therein be made and paid into the General Revenue Fund by the board instead of by the Provincial Treasurer.
 - (4) On or before the last day of each month the board shall make a contribution to the General Revenue Fund of an amount
 - (a) equal to the contribution by the employee if the same does not exceed five per cent of his salary, or
 - (b) at the rate of five per cent of the salary of the employee if the rate of contribution by the employee exceeds five per cent of his salary.
- 6. This Act comes into force on the day upon which it is assented to.
