A Bill to amend Le College St. Jean d'Edmonton Act

An Act to amend Le College St. Jean d'Edmonton Act

(Assented to , 1963)

Preamble

WHEREAS a petition has been presented praying for an amendment to An Act to Incorporate Le College St. Jean d'Edmonton, being chapter 94 of the Statutes of Alberta, 1961, for the purpose of exempting from assessment and taxation certain property located in the City of Edmonton, Alberta; and

WHEREAS it is expedient to grant the said petition.

THEREFORE, Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

New
section 6a

1. *Le College St. Jean d'Edmonton Act*, being chapter 94 of the Statutes of Alberta, 1961, is hereby amended by adding the following section after section 6.

Exemption
from
taxation

6a. The following property, namely,

- (1) All that portion of Section Twenty-eight (28), of Township Fifty-two (52), Range Twenty-four (24), West of the Fourth Meridian, in the Province of Alberta, in the Dominion of Canada, described as follows:

Commencing at a post planted on the East boundary of said Section Twenty-eight (28) at a distance of Forty-three (43) chains, North from the South East corner of said Section Twenty-eight (28) thence West at right angles with the said East boundary a distance of Sixteen (16) chains and Seventeen (17) links to a post planted on the East boundary of Rutherford Park, thence north along the said East boundary of said Park a distance of Four (4) chains and Twenty-five (25) links to a post planted, thence East a distance of Sixteen (16) chains and Seventeen (17) links to a post planted on the East boundary of said Section Twenty-eight (28), thence South along said East boundary a distance of Four (4) chains and Twenty-five (25) links to the place of commencement, reserving thereout and therefrom for a street a strip of land One (1) chain wide and Four (4) chains and Twenty-five (25) links long across said land as shown on a plan attached to D.B. No. 4167 AB,

the land hereby described containing Six and Four Hundred and Forty-three Thousands (6 443/1000) acres, more or less as shown on Certificate of Title 185-M-12.

- (2) All that portion of Section Twenty-eight (28), Township Fifty-two (52) Range Twenty-four (24) West of the Fourth Meridian in the Province of Alberta, Dominion of Canada, described as follows:

Commencing at an iron bar planted Eight (8) chains and Fifty (50) links South from the North East corner of said section; thence Southerly along the East boundary of said Section a distance of Five (5) chains and Twenty-five (25) links to an iron bar; thence West at right angles to the said East boundary a distance of Sixteen (16) chains and Seventeen (17) links to the East boundary of Rutherford Park, thence North parallel to the East boundary of said Section Twenty-eight (28) a distance of Five (5) chains and Twenty-five (25) links thence East a distance of Sixteen (16) chains and Seventeen (17) links to the place of commencement, containing Eight and Forty-nine hundredths (8 49/100) acres more or less, together with a strip of land One (1) chain in width and Four (4) chains and Twenty-five (25) links long and shown as a part reserved on a plan attached to DB No. 4167 AB., as shown on Certificate of Title 84-R-13,

shall be exempt from assessment and taxation so long as the same are used for educational purposes, except for local improvement taxes and taxes pertaining to minerals.

Commence- **2.** This Act comes into force on the day upon which
