An Act to amend An Act to Incorporate the Sisters of Our
Lady of Charity of the Refuge

(Assented to _____, 1963)

Preamble

WHEREAS a petition has been presented praying for an amendment to the Act incorporating the Sisters of Our Lady of Charity of the Refuge, being chapter 85 of the Statutes of Alberta, 1913 (First Session) for exempting from taxation certain property located in the City of Edmonton, in the Province of Alberta; and

WHEREAS it is expedient to grant the said petition.

THEREFORE, Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

New
section 10a

1. An Act to Incorporate the Sisters of Our Lady of Charity of the Refuge, being chapter 85 of the Statutes of Alberta, 1913, is amended by adding after section 10 thereof the following new section:

Tax
exemption

10a. The following property, namely:

Firstly: Block (F) as shown on Subdivision Plan 4649 H.W. in the City of Edmonton, in the Province of Alberta, containing Three and Twenty-three Hundredths (3.23) acres more or less. Excepting thereout: Those portions of the said Block (F) taken for roadway as shown on Subdivision Plan 157 K.S. (Forest Heights, R.L. 25-A). Reserving thereout all mines and minerals.

Secondly: Block (A) as shown on Subdivision Plan 7627 A.Q. in the City of Edmonton, in the Province of Alberta, containing Twenty-one and Forty-four Hundredths (21.44) acres more or less. Excepting thereout:

- (a) Parcel (D) as shown on Filed Plan 820 E.O. containing Fifty-five Hundredths (0.55) of an acre more or less.
- (b) That portion in the said Block (A) taken for roadway as shown on Subdivision Plan 4649 H.W. containing One and Sixty-three Hundredths (1.63) acres more or less.

Reserving thereout all mines and minerals.

Thirdly: All coal which may be found to exist within, upon or under all of that portion of the said Block (A) described as follows: Commencing at the south-westerly

corner of the said Block (A); thence northerly along the westerly boundary of the said Block (A) Three Hundred and seventy (370) feet; thence due east Four Hundred and Sixty-seven (467) feet; thence due south Four Hundred and Fifty-five (455) feet more or less to a point on the southerly boundary of said Block (A); thence westerly along the said southerly boundary to the point of commencement. Excepting thereout all that portion as described in Certificate of Title 182-A-51 and shown on Plan attached to Instrument 2577 C.K. The land hereby described containing Three and Forty-six Hundredths (3.46) acres more or less;

shall be exempt from taxation so long as the same are used for charitable and educational purposes, except for local improvement taxes and taxes pertaining to minerals.

Commence-
ment of Act

2. This Act comes into force on the day upon which it is assented to.
