BILL 32

A Bill to amend The Alberta Racing Commission Act

Explanatory Note

2. Section 7 provides for all employees of the Commission to be appointed by the Commission. Section 7 presently reads:

"7. Subject to The Public Service Act, the Lieutenant Governor in Council may appoint such officers, clerks and employees as may be required for the proper conduct of the business of the Commission."

Section 8 provides for all salaries and expenses to be paid out of the revenue of the Commission. Section 8 presently reads:

"8. The salaries and expenses of the members of the Commission and of the officers, clerks and other employees thereof, and generally all costs, charges and expenses incurred and payable in respect of the carrying out of this Act, shall be paid out of the moneys appropriated therefor by the Legislature."

3. Section 11 presently reads:

"11. The Commission shall make a report annually to the Minister containing such information as the Minister requires."

4. Section 13 provides for any surplus revenue to be paid into the General Revenue Fund. Section 13 presently reads:

"13. All revenue of the Commission, including licence fees and penalties, shall be paid into and form part of the General Revenue Fund of the Province."

An Act to amend The Alberta Racing Commission Act

(Assented to _____, 1963)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. *The Alberta Racing Commission Act*, being chapter 76 of the Statutes of Alberta, 1962, is hereby amended.

2. Sections 7 and 8 are struck out and the following sections are substituted:

7. The Commission may appoint such officers, clerks and employees as may be required for the proper conduct of the business of the Commission.

8. The salaries and expenses of the members of the Commission and of the officers, clerks and other employees thereof, and generally all costs, charges and expenses incurred and payable in respect of the carrying out of this Act, shall be paid out of the revenue of the Commission.

3. Section 11 is amended by renumbering the section as subsection (1) and by adding the following immediately after the renumbered subsection (1):

(2) The Minister shall lay a copy of the report of the Commission before the Legislative Assembly within fifteen days after the commencement of the next ensuing session.

4. Section 13 is struck out and the following section is substituted:

13. The Lieutenant Governor in Council may direct that any surplus of revenues of the Commission be paid into the General Revenue Fund and that any deficit of the Commission be paid out of the General Revenue Fund.

5. This Act comes into force on the day upon which it is assented to.
