## **BILL 34**

A Bill to amend The Municipal and Provincial  
Properties Valuation Act

## **Explanatory Note**

### **2. Section 2, clause (d) presently reads:**

"(d) 'municipality' means a city, town, new town, village, county, municipal district, improvement district or special area;"

The amendment will have the effect of authorizing the preparation of a separate assessment within the boundaries of a school district within a national park.

### **3. Section 5 presently reads:**

"5. Not later than the thirty-first day of December in each year the Chief Provincial Assessor shall make or cause to be made on his behalf a valuation for each municipality of all installations, materials, devices, fittings, apparatus, appliances, equipment, machinery, ways and easements and structures, other than land and buildings, owned by and used in the communication system of the Alberta Government Telephones Commission."

The amendment is to facilitate the carrying out of certain administrative procedures at the earliest possible date after January 1st in each year.

### **4. Section 7, subsection (1) presently reads:**

"7. (1) The valuation required pursuant to section 3 or 4 shall be prepared not later than the thirty-first day of December in any year for the purposes of this Act in the next succeeding year."

**H**ER MAJESTY, by and with the advice and consent of  
the Legislative Assembly of the Province of Alberta,  
enacts as follows:

**1.** *The Municipal and Provincial Properties Valuation Act*, being chapter 53 of the Statutes of Alberta, 1961, is hereby amended.

**2.** Section 2, clause (d) is amended by striking out the words "or special area" and by substituting the words ", special area or school district within a national park".

**3.** Section 5 is amended by striking out the word "December" and by substituting the word "October".

**4.** Section 7, subsection (1) is amended by striking out the word "December" and by substituting the word "October".

**5.** This Act comes into force on the day upon which it is assented to and upon so coming into force section 2 shall be deemed to have been in force at all times on and after the thirtieth day of December, 1962.
