Most Gracious Sovereign:

WHEREAS is appears by Messages from His Honour, J. Percy Page, Lieutenant Governor of the Province of Alberta, and the Estimates accompanying the said Messages, that the sums hereinafter mentioned are required to defray certain expenses of the Public Service of Alberta not otherwise provided for during the financial periods ending respectively, the Thirty-first day of March, One Thousand, Nine Hundred and Sixty-three, the Thirty-first Day of March, One Thousand, Nine Hundred and Sixty-four, and the Thirty-first Day of March, One Thousand, Nine Hundred and Sixty-five, and for other purposes relating thereto:

MAY IT THEREFORE PLEASE YOUR MAJESTY that it be enacted and be it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, as follows:

- 1. This Act may be cited as "The Appropriation Act, 1964".
- 2. From and out of the General Revenue Fund there may be paid and applied a sum not exceeding in the whole, Three Hundred and Eighty-one Thousand Fifty-eight Dollars and Sixty-four Cents towards defraying the several charges and expenses of the Public Service from the First day of April, One Thousand, Nine Hundred and Sixty-two, to the Thirty-first day of March, One Thousand, Nine Hundred and Sixty-three, not otherwise provided for and set forth in Schedule "A" to this Act.
- 3. From and out of the General Revenue Funds, there may be paid and applied a sum not exceeding in the whole, Eighteen Million, Five Hundred and Twenty-five Thousand, Eight Hundred and Seventy-three Dollars and Forty-six

Cents, towards defraying the several charges and expenses of the Public Service from the First day of April, One Thousand, Nine Hundred and Sixty-three to the Thirty-first day of March, One Thousand, Nine Hundred and Sixty-four not otherwise provided for and set forth in Schedule "B" to this Act.

- 4. From and out of the General Revenue Fund, there may be paid and applied a sum not exceeding Four Hundred and Fourteen Million, Four Hundred and Eighty-nine Thousand, Eight Hundred and Forty-four Dollars, towards defraying the several charges and expenses of the Public Service from the first day of April, One Thousand, Nine Hundred and Sixty-four, to the Thirty-first day of March, One Thousand, Nine Hundred and Sixty-five, not otherwise provided for, and set forth in Schedule "C" to this Act.
- 5. The due application of all moneys expended under this Act shall be accounted for.
- 6. This Act shall come into force on the day upon which it is assented to.
