# BILL

No. 11 of 1964

An Act to amend An Act to Incorporate Les Filles de Jesus

(Assented to \_\_\_\_\_, 1964)

Preamble

**WHEREAS** a petition has been presented praying for an amendment to An Act to Incorporate Les Filles de Jesus, being chapter 33 of the Statutes of Alberta, 1909, for the purpose of exempting from assessment and taxation certain property located in the City of Edmonton, the property of the said corporation, and

**WHEREAS** it is expedient to grant the said petition;

**THEREFORE**, Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

An Act to Incorporate Les Filles de Jesus, being chapter 33 of the Statutes of Alberta, 1909, is hereby amended.

s. 8

**1.** Section 8 is amended by renumbering the section as subsection (1) and by adding the following subsection:

Validity of  
by-laws

(2) No by-law shall be valid or take effect unless or until it has been approved by the Mother General of Les Filles de Jesus.

Enacts  
s. 13A

**2.** The following section is added after section 13:

Tax  
exemption

**13A.** The following property, namely:

Block Two (2) containing three and eighty-three hundredths (3.83) acres, more or less, in the City of Edmonton, in the Province of Alberta, Dominion of Canada, as shown on Subdivision Plan 6900 R. (Scona Brae—Frac. N.W. 27-52-24-W4th) Reserving thereout all mines and minerals, and

Lot "X" containing three and ninety-five hundredths (3.95) acres more or less in Block "B" in the Townsite of Morinville, aforesaid, as shown on Subdivision Plan 7732 R. (N.E. 33-55-25-4). Reserving unto Her Majesty all mines and minerals,

together with the buildings located thereon shall be exempt from assessment and taxation so long as the same are used for objects of the Corporation, except for local improvement taxes and taxes pertaining to minerals.

**3.** This Act comes into force on the day upon which it is assented to.
