A Bill to amend The Bread Act

Explanatory Note

- 1. The Bread Act, R.S.A. 1955, c. 31, amended.
- 2. Section 2, clause (d) presently reads:
 - "(d) "fancy bread" means all crimp, French, rye, Vienna, twist or cottage bread or any other style of bread not made by the ordinary process and generally known to the trade and to the public as fancy bread;".
- 3. Section 3 reads:
 - "3. No person shall use the basement or cellar of a building as a bake shop.".
- 4. Section 5, subsection (1), clause (b) presently reads:
 - "5, (1) No person shall make bread in a bake shop for sale otherwise than
 - (b) in the case of fancy bread, in loaves which shall weigh not less than eighteen nor more than eighteen and one-half ounces each, or in the case of larger loaves any even multiple of those weights, or".
- 5. New wrapping and labelling requirements for bread not sold on the premises where it is made.

- 6. Section 18 reads:
 - "18. (1) No person shall sell bread or any bakery product on the condition that the purchaser may return the same.
- (2) No person who has sold any bread or any bakery product shall take back or exchange any bread or any bakery product previously sold by him to a distributor.".

An Act to amend The Bread Act

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

- 1. The Bread Act is hereby amended.
- 2. Section 2, clause (d) is amended by adding after the word "rye," the figure and words "100 per cent whole wheat,".
 - 3. Section 3 is repealed.
- 4. Section 5, subsection (1) is amended by striking out clause (b) and by substituting the following:
 - (b) in the case of fancy bread, in loaves which shall weigh
 - (i) not less than nine ounces and not more than nine and one-half ounces, or
 - (ii) not less than eighteen ounces and not more than eighteen and one-half ounces, or
 - (iii) not less than twenty-seven ounces and not more than twenty-seven and one-half ounces, or
 - (iv) not less than thirty-six ounces and not more than thirty-six and one-half ounces,

or

- **5.** The following section is added after section 10:
- 10a. (1) No person shall offer for sale any bread unless
- (a) it is contained in a bag or is wrapped, and
- (b) the bag or wrapper shows the name or trade-mark of the manufacturer of the bread and the weight of the bread in ounces.
- (2) Subsection (1) does not apply where the bread is sold in the premises where it is made or in premises operated by the manufacturer thereof, but in that case the manufacturer of the bread shall post in the premises in a place conspicuous to customers a notice showing the weight of each loaf of each class of bread sold.
 - 6. Section 18 is repealed.
- 7. This Act comes into force on the first day of July, 1964.
