# BILL

No. 28 of 1964

An Act to Provide for the Exemption of Certain Land which  
is the Property of The Canadian Red Cross  
Society from Assessment and Taxation

(Assented to \_\_\_\_\_, 1964)

Preamble

WHEREAS The Canadian Red Cross Society has presented a petition praying for an Act to provide for the exemption of certain land owned by The Canadian Red Cross Society or held in trust for its benefit, from assessment and taxation other than that relating to local improvements and it is expedient to grant the prayer of the said Petitioner:

THEREFORE, Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

Exemption  
from  
taxation

1. The following property situate in the Province of Alberta, described as follows:

(a) *Firstly*: The East half of Lot Twelve (12), the whole of Lots Thirteen (13) to Twenty-eight (28) inclusive and the East half of Lot Twenty-nine (29) all in Block Ninety-one (91), Plan A 1, Calgary.

*Secondly*: The Westerly Sixteen and five-tenths (16.5) feet of Lot A in said Block Ninety-one (91).

*Thirdly*: That portion of Lot "B" in said Block Ninety-one (91) which lies to the East of the most Westerly Two Hundred Eighty-seven and Five Tenths (287.5) feet thereof

(A) *Excepting firstly*: Out of the *Secondly* described the South One Hundred (100) feet of said portion of Lot A, as described in Transfer registered as 3717 GX,

(B) *Secondly*: Out of the *Firstly* described the South One Hundred (100) feet of Lots Twenty-one (21) to Twenty-six (26) inclusive as described in said Transfer registered as 3717 G.X.

Excepting out of all the above lands all mines and minerals.

(b) Lots One (1) to Six (6) inclusive and Lots Thirty-three (33), Thirty-four (34) and Thirty-five (35) all in Block One Hundred and Sixteen (116), Plan C, Calgary.

(c) Lot Seven (7) in Block Twenty-one (21), Plan Medicine Hat 1491. Excepting thereout all mines and minerals.

(d) Lots Five (5) and Six (6), Plan Lethbridge 5728 S, subject to the Right of Expropriation of certain portions thereof and to such other rights and conditions as are set forth in Transfer registered as 2037 C. Reserving unto Her Majesty all coal and the right to work the same,

shall be exempt from assessment and taxation, other than taxes relating to local improvements and taxes pertaining to minerals, so long as it shall remain registered in the name of The Canadian Red Cross Society and owned by it or held in trust for it and used by it for or in connection with benevolent purposes.

**Commence-  
ment of Act**

**2.** This Act comes into force on the day upon which it is assented to.
