Preamble

WHEREAS The Sisters, Faithful Companions of Jesus, Calgary, Alberta, has presented a Petition praying for an Act to provide for the exemption of certain lands belonging to The Sisters, Faithful Companions of Jesus, in or near the Cities of Calgary, Edmonton and Lethbridge from assessment and taxation other than taxes relating to local improvements and minerals, and it is expedient to grant the prayer of the said Petitioner:

THEREFORE, Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

Exemption from taxation

- 1. The following properties, namely:
- (a) Lands located at the City of Calgary, in the Province of Alberta, and described as follows, namely:

Firstly: That portion of Lot Five (5) which lies to the West of the production Southerly of the West boundary of Lot Four (4) and all of Lots Six (6) and Seven (7) in Block Eleven (11);

Secondly: That portion of Lot Sixteen (16) which lies to the East of the West eighteen (18) feet thereof and all of Lots Seventeen (17) to Twenty-two (22) inclusive in Block Eighteen (18);

Thirdly: The South thirty-three (33) feet of Lots Thirteen (13) to Fifteen (15) inclusive, and the South thirty-three (33) feet of the West eighteen (18) feet of Lot Sixteen (16) and that portion of Lot Sixteen (16) which lies to the East of the West eighteen (18) feet thereof, and all of Lots Seventeen (17) to Nineteen (19) inclusive in Block Twenty (20);

Fourthly: Lots Thirteen (13) to Eighteen (18) inclusive in Block Twenty-two (22).

(b) Lands located at the City of Lethbridge, in the Province of Alberta, and described as follows, namely:

Lots Twelve (12) to Twenty (20) inclusive and

all of Lots Thirty-Five (35) to Forty-five (45) all inclusive, and Lot A, all in Block One Hundred and Eighteen (118) according to a plan of part of the City of Lethbridge of record in the Land Titles Office for the South Alberta Land Registration District as Plan Lethbridge 4353 S.

Reserving unto Her Majesty, Her Successors and Assigns all mines and minerals and the right to work the same.

- (c) Lands located at the City of Edmonton, in the Province of Alberta, and described as follows, namely:
 - (i) Lots Twenty-one (21), Twenty-two (22) and Twenty-three (23), in Block Nine (9) as shown on a plan of part of the Hudson's Bay Company's Reserve in the City of Edmonton, in the Province of Alberta, Dominion of Canada, of record in the Land Titles Office for the North Alberta Land Registration District as Plan B.
 - (ii) Lots numbered Twenty-one (21), Twenty-two (22) and Twenty-three (23) and Lots Sixty-four (64), Sixty-five (65) and Sixty-six (66) inclusive in Block numbered Ten (10) as shown on a plan of the Hudson's Bay Company's Reserve, in the City of Edmonton, in the Province of Alberta, Dominion of Canada, of record in the Land Titles Office for the North Alberta Land Registration District as Plan B.
- (d) Lands located near the City of Edmonton, in the Province of Alberta, and described as follows, namely:

The portion of the West half of Section Thirtyone (31), Township Fifty-one (51), Range Twenty-four (24), West of the Fourth Meridian, which said lands are described in Certificate of Title No. 192-Q-196 in the Land Titles Office for the North Alberta Land Registration District.

shall be exempt from assessment and taxation other than taxes relating to local improvements and minerals, for so long as it shall remain registered in the name of The Sisters, Faithful Companions of Jesus, and owned by it, and used by it, for or in connection with the provision of facilities for Divine worship, charitable purposes and the provision of educational and training facilities for young girls and young ladies seeking to devote their lives to the Sisterhood.

Commencement of Act 5. This Act comes into force on the day upon which it is assented to.
